Winners of the Achievement Awards

Pat Morris was selected as the 2023 Citizen of the Year, and Barbara Davis, Don Hampton, and Mary Ann Redinger received a Lifetime Achievement Award. A dinner to honor them was held at the Ponce Inlet Community Center on March 30th and was attended by friends, family, and town representatives.

Pat Morris



Pat and her husband Mark, last year's Citizen of the Year, decided to relocate to Ponce Inlet in 2014 after retiring from their careers in Pennsylvania. When they arrived, they knew they both wanted to become active volunteers in their new hometown.

After permanently moving to Ponce Inlet in 2015, Pat joined the Ponce Inlet Lions Club, where she became a director for several years and served as the club secretary from 2019-2021. Although no longer on the board, Pat continues to serve the Lions Club and has worked with her husband Mark for the past three years to organize and manage the Lions Club annual fundraising golf tournament.

This event is the Lions Club's largest fundraiser of the year and last year raised over \$12,000. Pat, who is working again with her husband and the Lions, is also responsible for the RJ Longstreet elementary school pantry, which provides assistance to food insecure children and families. Prior to COVID, Pat was also a first grade teacher assistant at the school.

Pat previously volunteered at the Ponce Inlet Lighthouse as a lighthouse guide for two years prior to COVID. In doing so, Pat enjoyed meeting out-oftown visitors, schoolchildren, and residents of our community, all while learning about the history of the Ponce Inlet Lighthouse. Pat especially enjoyed her tours with the schoolchildren and volunteering for the Climb to the Moon events at the lighthouse.

Pat currently serves on the Ponce Inlet Community Center Board of Trustees and has done so since 2019. She is an active participant on the PICC Board and enjoys working on various fundraising events, including the Community Center's Flea Market, Soup and Salad, and Frank Sinatra, and Irish Night Parties.

Pat also worked with other volunteer board members to improve the appearance of the center and regularly volunteers in the Community Center office.

In 2019, Pat joined the Garden Club of Ponce Inlet and, in 2020, began serving on its Board of Directors. Her first director position with the Garden Club was as first vice president. In November 2021, Pat took over as president of the club when the previous president resigned. Pat is passionate about being a member and president of the Garden Club and has recently been elected as president until 2025. For the past 3 years, Pat has co-chaired the Garden Club's annual Art, Craft, and Plant show, held each October. This particular show, for those who don't know, has been in our community for 40 years.

Pat helps organize and run the annual Ice Cream Social, a fun event for our community residents, and participates in the Ponce Inlet Christmas parade, and Ponce Preserves Planet. Pat clearly enjoys meeting and working with Garden Club members and looks forward to serving as their president again.

Most recently, Pat volunteered to become a director with C4PI. In this new role, one of Pat's primary responsibilities will be monitoring the C4PI website. Pat looks forward to serving on the C4PI board and will continue to volunteer and serve our community in any way possible.

Barbara Davis



In recognition of her numerous volunteer efforts, Barbara Davis received the Citizen of the Year Award 27 years ago.

Barbara has a long history of giving back to the community. She relocated to Ponce Inlet in 1989, and a year later she was chosen to serve on the inaugural Advisory Committee. From there, she worked with Animal Control Services and was the Chair of the Tree Board as well as a member of the Ordinance Review Committee. She was on the Planning Commission – twice.

She served as the treasurer of the Committee for Ponce Preserve, which raised money for it, and she chaired the Friends of Ponce Preserve for two years. From 2008 to 2011, Barbara served on the Town Council as Vice Mayor.


In addition, she was the Ponce Inlet coordinator for the Coastal and River Clean Up, a delegate to the Halifax/Indian River Task Force, and member of the Ponce Inlet Visioning Committee.

For the Marine Science Center's fundraising efforts this year, she created a Christmas Tree with uniquely designed and painted wooden ornaments and a beautifully painted wooden surfboard. When requested to assist with an art project, she is always willing to do so, and whenever she learns that a young person in the community wants to learn to draw or play music, she is ready with art materials or musical instruments. Barbara has consistently advocated for the protection of trees and parks, and most recently she encouraged the town to construct a pickleball court at Pollard Park.

Don Hampton



Don is a true native Floridian. Born in Halifax hospital, Don grew up in the Daytona Beach area and moved with his family to Ponce Inlet in 1972. Following in the footsteps of his mother Wilda, Don has been involved in community service for many years. After living here full time for 35 years, Don has become one of the "old timers" of Ponce Inlet.

Don served on the Ponce Inlet Lighthouse Association Board of Trustees for over 10 years. In 1999, Don was elected to the Town Council and served as a Council Member and Vice Mayor until 2001.

After his term on the Town Council, Don continued his community service on the Planning Commission in 2002.

That same year, the town began a visioning process, a project called "Charting a Course for Ponce Inlet", and Don was appointed to that committee. He and the committee worked closely with an outside facilitator to create the vision statement for Ponce Inlet, which is the foundational touchstone that guides us today.

In 2012, Don was named C4PI's Citizen of the Year for his many years of volunteer service to our community.

Don has been a board member of C4PI for over 20 years, most of which he served as president. He also edited the organization's newsletter for 10 of those years.

Don just stepped down from his position as President of the organization a few weeks ago and continues as an executive advisor on the Advisory Board.

Ponce Inlet is very fortunate to have such a dedicated and loyal resident who has been willing to sacrifice such a tremendous amount of their time to help make Ponce Inlet such a great place for all of us.

Mary Ann Redinger



Mary Ann and her husband, Alan, moved to Ponce Inlet in 1992, and she soon began volunteering at the community center.

Through her friendship with Kay Davies, a PICCI board member and wife of Ponce Inlet's first mayor, Mary Ann became a member of the board and served as recording secretary for over 20 years. You can still find Mary Ann in the PICCI office as a dedicated volunteer.

Mary Ann became a member of Citizens for Ponce Inlet in the early 1990s. As treasurer, she initially sent postcards once a year to remind people to pay the \$10 membership fee. The newsletters were then personally delivered to each residence. Mary Ann received the Citizen of the Year Award in 2005 in recognition of her dedicated volunteer work.

One of Mary Ann's all-time favorite organizations is the Garden Club. She has held the positions of recording secretary and treasurer. She participated in all Garden Club endeavors, including the Arts & Crafts show and other fundraising events.

Mary Ann never hesitates to step up and pitch in when needed. She continues to volunteer as a street guard at the Christmas and Legends Parades.

Mary Ann and her husband established the cat colony at Jerry's when there were approximately 17 feral cats. They would trap, neuter, and release them. Currently, there are only two cats left in this colony, and a group of volunteers provides them with food and care on a daily basis.

Eighteen years after being named Citizen of the Year, and thirty-one years of volunteer service to our town, we congratulate Mary Ann on receiving the Lifetime Achievement Award.

A Moment with the Mayor

Ponce Inlet's Town Manager Executive Search

Ponce Inlet's Town Charter provides for a Town Manager who serves as the Chief Administrative Officer of the Town. The Town Manager is responsible for the operation of the Town government and is directly accountable to the Town Council.

On June 22, 2022, after 12 years as our Town Manager, Jeaneen Witt tendered her resignation. The Council subsequently commenced a screening and selection process for hiring a new Town Manager, while taking steps to ensure there would be no disruption of the high level of services our residents have come to expect. Another important consideration was the impact the resignation and transition would have on our Town staff. Council recognized that it was imperative to ensure that our talented pool of employees remains and continues to implement the goals and objectives our Town has adopted.

Council engaged a professional recruiting firm to conduct a nationwide search for a new manager and approved a transition plan to provide continued management until a new manager could be selected. A cornerstone of this plan involved dividing the existing responsibilities between two current internal staff members.

Mike Disher, the Planning and Development Director, was appointed as Interim Town Manager, and Fire Chief Dan Scales was appointed in a newly created role as our Public Safety Director Pro Tem. Under this plan, the Police, Fire, Public Works, and Information Technology Divisions report to Public Safety Director Pro Tem Scales, and the Public Safety Pro Tem, along with

Finance, Human Resources/Deputy Clerk, Planning and Development, and Cultural Services Divisions, report to Interim Town Manager Disher.


Interim manager Disher and Public Safety Director Pro Tem Scales led the town through back-to-back hurricanes, pursued grants and appropriations aimed at increasing our resilience, and for the first time in 22 years, entered into a contract with Ponce Inlet's Fire Union Local 4140.

The Town received a significant number of applications for the position of Ponce Inlet Town Manager, and after completion of the review and interview process, Mike Disher, by a unanimous vote, was offered the position.

We are delighted to make this internal promotion with such a qualified and dedicated person as Mr. Disher. His many years of valuable experience with the Town and his working relationships with Town staff make him an ideal fit for Ponce Inlet. Congratulations Mr. Disher.

The Mayor in Tallahassee

The Florida Legislature's regular session commenced in Tallahassee on March 7, 2023, and will end on May 5, 2023. Throughout the legislative session, I am engaged with our state leaders to advocate on behalf of Ponce Inlet and our residents. During the week of April 3, I traveled to Tallahassee to meet in person with our legislators for discussions focusing on the Town's appropriations requests, bills of local concern, and our residents' needs relating to the restoration of our beaches and the armoring of vulnerable properties.



Following the advocacy efforts by Volusia County, local officials, and state legislators, the Florida Department of Environmental Protection (DEP) and Florida Fish and Wildlife (FWC) announced a significant modification to the restrictive rules preventing work from taking place during turtle nesting season.

On April 14, 2023, FWC provided additional guidance to Volusia County residents that will permit coastal armoring projects to

begin and continue throughout the turtle nesting season, provided FWC wildlife protection guidelines are met. Prior to this notification by the FWC, property owners who had not started their construction by May 1 were not permitted to begin their coastal armament work until the end of turtle nesting season on November 1, leaving some properties at risk for further damage by hurricanes and the elements. In addition, permit applications may now be submitted after the May 1 deadline.

Finally, the County's long-awaited plans for the replenishment of sand on our beach are taking shape. According to information released by the County, approximately 550,000 cubic yards of sand currently situated on Rattlesnake Island have been earmarked for deposition on the beach, starting at the jetty and working northward. We look forward to learning more about the County's logistical plans and timeline in the near future.

COUNTY CORNER

Let me start off by introducing myself. I am Matt Reinhart, your County Councilman for District 2. I was elected to this position by the voters of Volusia County in November of 2022 and took office in January of this year. I come from an over 30-year career in law enforcement and retired as the Warden of the Volusia County Division of Corrections. I oversaw a budget of over \$30 million and approximately 350 civilian and uniformed personnel, 1300-1500 inmates and two institutions. As you can see, I have experience working with big budgets and people.

When I first began my campaign and started visiting communities in my district, I fell in love with the town of Ponce Inlet. In fact, I held one of my two fundraisers at the Ponce Inlet Community Center and held my "Thank You Celebration" at the same location after my election. There is such a sense of community here. I absolutely love Ponce Inlet.

After my election, I wanted to hit the ground running. Especially since it followed two horrific events (Hurricanes Ian and Nicole). County staff quickly became aware of the importance of doing what they could to assist our coastal neighbors. I remember being in a meeting at DeLand where I was speaking with our Growth Management Director. During that conversation, I discovered that there was a county ordinance that required coastal residents to place compatible beach sand on their property line where their sea wall required a four-foot dune and twelve foot extension.

I thought while construction was occurring this sand would just wash away. The question was then asked. Could we not defer this requirement for eighteen months to allow the natural accretion of sand to occur? This would potentially save the homeowner thousands of dollars that could be better spent on the structural repairs



needed at that time. That evening at Council, I asked for a resolution for a deferment until December of 2024 and the motion passed unanimously.

Anyone who lives on the coast quickly discovered that FDEP (Florida Department of Environmental Protection) "holds all the cards" when it comes to repairing and replacing sea walls. This agency follows the rules and ordinances set forth by the FWC (Florida Fish and Wildlife Conservation) Commission). This is due to the USFWS (United States Fish and Wildlife Service) Endangered Species Act, which aims to protect sea turtles and some shoreline birds. Part of the Endangered Species Act allows for those repairs, but not after sea turtle nesting season opens, which begins May 1. Discussions are ongoing between the County of Volusia and these agencies.

Recently, Volusia County finally received confirmation from the FWC to provide additional guidance on coastal construction activities after May 1 to private property owners who have received a Coastal Construction Control Line permit from the FDEP. It states property owners who have obtained an FDEP permit and have already begun or will begin construction by May 1 can continue as long as all permit conditions are met.

Property owners with an FDEP permit who were unable to begin construction before May 1 must contact the FWC to determine if the proposed site contains sea turtle nests before materials are delivered. Once the FWC certifies that the proposed construction site is clear of turtle nests, materials can be delivered and construction can begin. FWC staff will only inspect project sites that have received an FDEP permit during the turtle nesting season. Property owners can still apply for a permit from the FDEP after May 1st.

The approval should bring some relief to our coastal property owners who are still trying to rebuild after the storms.

Here are some other important facts we want our citizens know:

The trap bags have been purchased and sand for them has been obtained. This was done with the initial \$5 million from FDEP.

Volusia County received \$328,910,000 in Community Development Block Grants for Disaster Recovery (CDBG-DR). This is funded by HUD, funds are used for disaster relief, long-term recovery, restoration of infrastructure, housing, economic revitalization and mitigation in the hardest-hit and most needed areas after a presidentially declared disaster. I will tell you that I am asking for a review of the midtown and Beach Street area for this grant. However, public participation is strongly encouraged and implemented in a number of ways, including holding public meetings, soliciting comments and input, and publishing a draft of an action plan for review and feedback.

The initial steps to obtaining funding from HUD are to analyze the needs of the community and develop an action plan. For the process of analysis and community involvement, interested residents, agencies and municipalities can submit their contact information and a brief description of a the potential project based on currently known information. Sign up to receive updates and provide input by visiting volusia.org or using

As everyone probably already knows, \$37.6 million was received from the FDEP for beach renourishment. These state funds are earmarked for sand placement, a feasibility study that makes recommendations for a long-term (50-year) resiliency solution, and the initial project resulting from those recommendations. This will be a long-term project, lasting up to five years.

The Army Corps of Engineers awarded a \$3 million grant to fully fund the feasibility study. Usually, the \$3 million for the study is spread over three years, but in this case, the money is being allocated in the first year, which means that engineers can more quickly identify the problems, design solutions and begin real work. The study could begin as early as this spring.

The Army Corps of Engineers also has a permitted an Intracoastal Waterway dredging project. Sand is typically dredged every five years and dumped off shore in 8 to 12 feet of water. We are in conversation with them now to see if they will place it in one location on "Rattlesnake Island". This way, we could possibly have two "bites of the apple" from this location.



I know I have thrown a lot of content your way, but I am a firm believer in keeping everyone aware, updated, and informed.

From the Town Manager, Mike Disher

I am truly honored to be selected by the Town Council as your new Town Manager. I've had the privilege of working for Ponce Inlet for 10 years now, starting as a Senior Planner in the Planning & Development Department and then later returning as the Assistant Director and then Director of that department. Last summer I was asked to serve as the Interim Town Manager following the resignation of Jeaneen Witt. This role officially started for me after her last day this past October. In March of this year, the Town Council interviewed me for a permanent role; and then made it official at the April Council meeting. I am extremely grateful for this opportunity and look forward to that all we can accomplish together.

One of the most rewarding aspects of this position has been working closely with each of the Town's department heads – learning about their responsibilities, challenges, expertise, and work ethic, and how each fits into the operation of the Town government as a whole. As a manager, my role will be to ensure that the Town staff maintains the highest levels of quality, integrity, and professionalism that Town Council and our residents expect. This expectation, reflected in the Town's mission statement, is one of the many qualities that set Ponce Inlet apart from other communities. Ponce Inlet has excellent staff members at all levels within the organization. If we can be of any assistance, please always feel free to contact us.

Hurricane Recovery Updates

Hurricanes Ian and Nicole caused damage to many of the Town's facilities, but repairs are underway and in some cases have already been completed. Renovated or replaced facilities include the Fire station



roof, the Community Center roof, the Inlet Point fountain electrical box, and soffit repair of Town buildings. Repairs currently in progress include fencing and exterior lighting around Town properties, and bollard lights at Timucuan Oaks Park. Several other repair projects will begin in the near future, including installing stairs at Ponce Preserve, repairing the boat ramp, and replacing the pergola at Timucuan Oaks. Staff has been working diligently to obtain reimbursement funds from the Town's insurer and FEMA.

In early April, the Town started clearing stormwater pipes in the areas of Coastal Oaks, Riverglen, and Calumet as well as other streets to the south that were most severely affected by last year's flooding.

To date, approximately one mile of pipes have been cleared. Removing the build-up of silt and muck from these pipes will help them function more efficiently. In addition, Public Works crews have now uncovered and constructed six storm drain outfall structures that allow stormwater runoff to flow freely. In many cases, the ends of the pipes were completely buried and blocked. To determine how much organic silt has accumulated at the bottom of our retention ponds, Public Works will also conduct soil tests in these areas. The ponds that

generate the most waste must be excavated to fully restore their capacity and function. Thanks to the expertise and hard work of the crews, we were able to significantly improve the condition of our drainage system. More details and photos about these events can be found in the Public Works section of this newsletter.

Town-wide Improvements

In addition to hurricane-related repairs, several additional projects have already been completed or will be soon, such as the Tina Maria Circle entrance walls, Elbers Park rip-rap revetment, Community Center sidewalk restoration, and construction of new offices and a conference room at Town Hall.

The Town will benefit from the South Peninsula Drive sidewalk repair project in terms of safety, recreation, and aesthetics. Town staff was recently informed that FDOT has advanced funding for the project's design and work could begin later this year. Your feedback is an integral part of the process as the design phase begins and community meetings are organized accordingly. In a few years, most likely in 2025 or 2026, construction is anticipated to begin.

Finally, the Town's engineering consultants have almost finished designing the remaining portions of the Sewer Master Plan, enabling us to apply for construction grants for all of our septic-to-sewer projects, including the one for Ponce de Leon Circle.

There is currently no funding or timeline for construction, but it cannot happen without community support. Our barrier island community prioritizes sustainability and resilience, and replacing in-ground septic systems with sanitary sewer lines is an important part of making Ponce Inlet more resilient. Construction is not yet scheduled or funded, but without community support, it cannot take place.



Town Regular Election August 22, 2023

Ponce Inlet's upcoming election is scheduled for Tuesday, August 22nd. There are three seats up for election on the Town Council this year. Mayor/Seat #1, Seat #3, and Seat 5 will be open for two-year terms. Oualified candidates must be a resident of the Town for at least 12 months and have been a Volusia County registered voter for 12 months prior to the qualifying period. The qualifying period begins on Monday, June 5th at 9:00 a.m. and ends on Friday, June 16th, at noon. Florida's Tropical Hurricane Season

Florida's tropical climate creates the potential for hurricanes six months each year. Although it seems like last year's hurricane just ended, the 2023 season begins on June 1st and runs through November 30th.

While weather service forecasts have improved over the years, the fact is that direction and speed of hurricanes change very quickly, so advance preparation is important. Planning & Development Department

Coastal Resiliency Planning

In 2020, the Town embarked on its planning efforts to improve its resiliency to future changes in sea level rise and storm events and to comply with the 2015 Peril of Flood (POF) Act. The Town hired staff from the East Central Florida Regional Planning Council (ECFRPC) to prepare a Vulnerability Assessment of critical infrastructure, conduct an online public survey, and provide policy recommendations for the Town's Comprehensive Plan. The proposed amendments to the Coastal Management Element and Future Land Use Element of the Plan were intended to comply with the six criteria of the POF and incorporate the results of the 2022 Vulnerability Assessment.

These proposed amendments to the Plan's goals, objectives, and policies were presented to the Planning Board in March and December 2022 for feedback from the Board and the public. In February of this year, the Planning Board recommended that the Town Council approve the proposed amendment ordinance. At its March 16, 2023 meeting, the Town Council approved the ordinance on first reading and directed staff to transmit the amendments to state and local reviewing agencies. If no objections are received, this ordinance will return to the Town Council for second reading and will take effect after the expiration of the mandatory 30-day appeal period.

Adopting these policies is a concrete first step in utilizing the data gathered from the Vulnerability Assessment to improve the Town's resilience to sea level rise and storms. These policies will be used to guide future development decisions, update development requirements, and infrastructure projects, and adapt to projected sea level rise.

Evaluation and Appraisal Report (EAR)

Florida Statutes require all local governments to review their comprehensive plans every seven years and evaluate if modifications are necessary during that period to comply with changes in state law. Town Staff reviewed the legislative changes from 2016 to 2022 and determined that there are a few updates that needed to be completed. A list of the applicable changes was compiled in the EAR notification letter presented to the Planning Board in August and accepted by the Town Council in September 2022.

Now that the EAR notification letter has been submitted to the Department of Economic Opportunity (DEO), the Town has one year to adopt the plan updates that were identified in the EAR letter. Staff are currently engaged in this process, which includes updates to the plan's Transportation, Public Facilities, and Capital Improvements Elements. The Town's transportation consultant recently completed a traffic study of the entire Town that will be used to support proposed changes to the Transportation Element. The Public Facilities Element will be updated to match the Level-of-Service Standards of the City of Port Orange, which supplies sanitary sewer service and potable water to the Town. Finally, the Capital Improvements Element will be updated to show proposed Town projects anticipated to be completed within the next five years.

While EAR updates are a minimum requirement to comply with state law, Town Staff will also work to update other areas of the Comprehensive plan after the EAR is completed. These additional updates are intended to modernize and reformat the document to make it easier to read, navigate, and apply the goals, objectives, and policies.

Temporary Garage Sale Signs

It is spring cleaning time again! After cleaning and de-cluttering your home and garage, you may be planning a garage sale. Please remember to apply for a garage sale sign permit before setting out items for your event. Garage sales are allowed from 8:30 a.m. to 5:00 p.m. for a maximum of three consecutive days. Up to three events may be held each calendar year. Garage sale signs must be no larger than two square feet. Permit applications can be obtained from the front counter at the main entrance of Town Hall. In January of 2023, the Fire Department responded to a significant structure fire in Ponce Inlet and was assisted by the cities of Port Orange, South Daytona, and Daytona Beach Shores.





The fire department also received the latest self-contained breathing apparatus (SCBA) in January. The new units are state-of-the-art in design, with advanced communication capabilities and built-in infrared fire detection devices. The new SCBA equipment significantly improves the

safety and efficiency of firefighters.



The Fire Department's accreditation team completed the Standard of Cover/Community Risk Assessment document and submitted it for editing. We hope to publish the document within the next few months. This accomplishment represents a significant milestone in Fire Department accreditation. The document also provides information to the public about the operations of the Fire Department and the community we serve.

In February and March, the department applied for two federal grants, one for \$60,000 for new equipment and another for the addition of three more firefighters in the amount of \$955,010. We are optimistic that we will be successful in obtaining one or both grants. These grant projects are highly competitive with fire departments across the country competing for these funds.

Fire Department response data and turnout times can be reviewed on the Town's website under the fire department page. There are also links to informative maps that illustrate the concentration of calls.

About the Department

The Ponce Inlet Police Department operates 24/7 with 13 full-time officers, three part-time officers, and two civilian administrative staff. Our department is fully accredited by the Commission for Florida Law Enforcement Accreditation. Accreditation is a coveted award that symbolizes professionalism, excellence, and expertise. Each police officer is assigned a patrol car and works a 12-hour shift. We have one investigator who follows up on all reported crimes, handles property and evidence collection, audits training records, performs the required background checks on all town employees, and functions as a liaison between the State Attorney's Office and the Volusia County Sheriff's Office.

Beware of Fraud!

The most common crime in Ponce Inlet is fraud. Elderly victims are often targeted because they own their homes, have savings, are trustworthy and kind, and will often answer the phone and speak to solicitors. Last year, the Ponce Inlet Police Department developed a fraud class

and presented it to 30 residents at the Community Center; the Department offered a class on Wednesday, May 3rd. Remember, if it's too good to be true, it's probably a scam!

Bike Patrol

In an effort to reach more residents and engage with our citizens, the Ponce Inlet Police Department purchased two new police patrol bicycles and partnered with the Daytona Beach Police Department to certify four of our officers to patrol on bicycles. Patrol bikes allow us to better monitor the parks and pedestrian and bicycle paths throughout the town. The police department also purchased a battery-powered mobile radar gun to use on the sidewalks. The PIPD is also seeking a grant to purchase a golf cart so officers can patrol neighborhoods and work at parades, road races, and other special events.



Citizens Watch

The Ponce Inlet Citizens Watch Program is an important and valuable asset to the Ponce Inlet Police Department. Volunteer members are dedicated citizens who generously donate their time to assist the Police Department as additional "eyes and ears" in our community. The member's duties include residential security checks, miscellaneous pick-up and delivery services for the police department, and regular

patrols throughout the town. Our members are provided with a vehicle equipped with amber warning lights, police radios, flashlights, traffic vests, raincoats, first aid kits, and fire extinguishers. Our members currently patrol for 1-2 hours at a time. We also use members for some of the special events around Town throughout the year. We are always looking for more volunteers. If you are interested, please contact the Ponce Inlet Police Department at 386-236-2160 for an application. A background check is required before starting.

Ponce Partners

The Ponce Partners Program is designed as a safety net for people who have health problems, are elderly, or people living alone. Any resident can become a member by completing a short request form. By becoming a Ponce Partner, you simply agree to contact the Police Department by phone each day before noon. If we do not hear from you, we will call and ask if everything is OK. If we are unable to reach you by phone, we will send an Officer to check on your well-being. This program was created to ensure that our elderly citizens have some form of communication each day. We have great relationships with all of our Ponce Partners and look forward to their morning calls. From Public Works Manager, Fred Griffith...

The Public Works crew has been very busy performing their everyday normal functions such as mowing grass, trimming vegetation, keeping all of our Town facilities clean and sanitary, and making necessary repairs to everything you could imagine. Public Works ensures that our drinking water is safe through proper system monitoring, flushing fire hydrants, and taking water samples for testing. In addition to all of that, the Department has also been removing blockages from the ends of many storm



pipe outfalls at the south end of town to allow the storm pipes themselves to be cleaned. Below, please see a few examples of their exploits. So far we have identified at least six outfalls needing significant attention to allow them to flow freely.

The Town has approximately 1,600 linear feet of exfiltration stormpipe systems that generally have no outfall. They are designed to collect and then percolate water back into the ground through small holes in the pipes. Such systems are a low-cost effective method of drainage when the groundwater table is low. However, with no outfalls, what goes into these pipes will stay in these pipes. This means that the pipes must be cleaned out from time to time, which can be expensive. It is therefore incumbent on all of us to NOT pile leaves , branches, garbage , or litter on or near these structures or on the curbing where it will be washed into these structures. We need to all work together to ensure that only rain water enters the storm drain pipes in the future!





This was the before and after picture just after a small tree was removed growing out of the end of this pipe at Michael Lane.

See below near the Oceanside Village area. This is a stormwater mitered end section uncovered by town crews under a fence, 2.0' of earth, and three tv cables at Michael Lane. This easement must be opened up to be able to properly maintain the large retention area behind the 6' fence. Storm pipes are scheduled to be properly flushed and cleaned to allow for free flow into this retention pond.



This pipe cleaning truck uses a highpressure hose and vacuum system. This picture illustrates what we have been able to successfully flush and clean from several stormwater pipes. Several catfish were safely rescued and returned to the Beach Street ponds from whence they came. Our storm pipes are now quite clean and able to flow much more freely.



The northern boat dock near Davies Lighthouse Park was recently damaged during the hurricanes. We are currently in the process of hiring a structural engineer to evaluate and design plans for the dock repairs.



Demolition work was recently completed at the Ponce Preserve Dune Walkover to remove the remaining section of boardwalk beyond the gazebo, as now seen below. The Town will be constructing a staircase in the near future to reestablish access to the beach. Construction bids were reviewed by the Town Council at its April meeting. We are attempting to have it begun immediately and completed for the summer season. Design work is continuing on reconstruction of the handicap ramp, which will connect to the stairs but be built separately. We anticipate this ramp undergoing construction later in this calendar year.




Events and Programs

Lions Clubs International's mission is to empower volunteers to serve their communities, meet humanitarian needs, encourage peace, and promote international understanding through Lions clubs. Our motto is simply "We Serve", and serve we do! We are currently the largest service organization in the world, with 47,000 clubs in over 160 countries across the planet.

Since our founding, the Ponce Inlet Lions Club has raised and donated hundreds of thousands of dollars to charity. Past projects have included fundraising for a childhood cancer patient, eye surgeries, eye exams, eyeglasses for numerous individuals, hearing aids, and more as detailed below. This summer, Ponce Inlet Animal Welfare (PAW) will celebrate the 14th anniversary of its founding. PAW has supported the townsanctioned trap-neuter-return/release (TNR) colony since 2009. Co-founders Alan Redinger and Jo Ellen Basile filed articles of incorporation with the state on June 26th. At the time, the town had been struggling with a feral cat problem since the early '90s. At one point, volunteers Barbara Davis and Beth Liebert trapped almost 300 cats! However, by 2009, the cat population was rebounding and was concentrated near the dumpster next to Jerry's restaurant where some well-meaning people were feeding them.

Alan and JoEllen decided it was time to step in to help. Working with Pat Mihalic and Concerned Citizens for Animal Welfare, they developed appropriate guidelines, and two Ormond Beach animal control officers assisted by sharing the forms and procedures they had developed. The property owner's consent was obtained, and the colony was officially established when the town council approved a TNR ordinance on August 20, 2009. A one-year pilot program was authorized, and following the pilot program period, all cats had been sterilized, and the original 22 cats had been reduced to five. The same five cats were

there for several more years, although all except Ruthie have passed away in the past few years.

Volunteers have cared for the cats daily since 2009, visiting once per day to feed them, put out fresh water, clean up the area as needed, and take any sick or injured cats for veterinary care.

Thank you to those generous residents who have donated food and money.

We are now down to only two full-time residents, Ruthie Grace, an original colony resident, and the mama cat, Tiki, who has only been there a couple of years. Sadly, Ruthie is showing signs of illness and we don't expect to have her with us much longer. Tiki had her kittens near the colony in May 2020, and the staff at Jerry's trapped the kittens. We have got them all adopted following spay and neuter, but we have not been able to trap Tiki. She is a sweet and very pretty girl, and she needs a forever home. Fall will bring the sad anniversaries of the passing of our founders, Alan Redinger and Jo Ellen Basile. Alan died on October 16, 2012, and Jo Ellen passed away from us on September 11, 2016. Shortly before his death, Alan was able to see the opening of the Redinger Spay/Neuter Clinic. The clinic offers low-cost sterilization services for both cats and dogs, as well as shots and microchipping. https://www.halifaxhumanesociety.org/spay-neuter-clinic/index To prevent stories like Tiki's, please get your pets spayed or neutered!

PAW can share options with you if you have financial or other challenges. Cats reproduce several times a year and the population can explode in a short period of time if both males and females are not made infertile.



A new year always brings new excitement to the Ponce Inlet Lighthouse and Museum

The first months of each year are always the busiest at the Ponce Inlet Lighthouse and Museum. School tours, adult programming, onsite educational opportunities, as well as outreach across Volusia County are prominent as the cold begins to shake off of Florida and people start enjoying the beautiful Florida sunshine again.



Watering Guidelines

Watering Restrictions

To ensure the efficient use of water for lawn and landscape irrigation, the St. John's River Water Management District has adopted watering restrictions. These restrictions are in effect year-round and apply throughout the District's entire 18-county area.

Rules & Regulations

During Daylight Savings Time the following rules apply:

Daylight Saving Time begins the second Sunday in March and ends the first Sunday in November. Residential irrigation is allowed at odd-numbered addresses from 4 p.m. to 10 a.m. Wednesdays and Saturdays and even-number addresses Thursdays and Sundays.

Business may irrigate from 4 p.m. to 10 a.m. Tuesdays and Fridays.

Restrictions apply to all water sources, including private wells and pumps, ground or surface water, and water from public and private utilities. New plantings may be watered any time for 30 days, then every other day for another 30 days. Keep the store receipt for proof of purchase. Hand watering with a spray nozzle that shuts-off when released is allowed anytime.

During Standard Time watering is allowed only once a week.

These guidelines apply to all areas in Volusia County, including cities:

- Water only when needed, and not between 10 a.m. and 4 p.m.
- Water for no more than one hour per zone, and no more than 3/4 inch per zone.
- Restrictions apply to all water sources, including private wells and pumps, ground and surface water, and water from public and private utilities.



Sea Turtle Nesting Season & Light Trespass

Sea turtle nesting season begins May 1 and runs through October 31.

Whenever human light shines into nature, it affects some aspect of animal life - migration, reproduction, hunting and feeding. The best studied incidence was observed in sea turtles. Sea turtle hatchlings instinctively know to head for the brightest light source, because hundreds of years before mankind mastered the dark, the starlight reflected from the ocean was the brightest on the coasts. But when coastal cities flood the night with their bright lights, the hatchlings, heading for the cities and not the sea, get confused and lost, falling victim to dehydration and predators and never reaching the ocean. In Florida alone, hatchling losses are in the hundreds of thousands each year.

Light trespass: A light emitted by an outdoor light source that shines beyond the property on which the fixture is installed, and causes annoyance, discomfort, distraction or a reduction in visibility.

Does more light make you safe?

Look around to see what lights are used at night. Is there good visibility around you, or does the unprotected light cause so much glare that visibility is poor? It is usually the latter.

Glaring lights cause hazards in the dark due to poor visibility. But there are also simple solutions: shielding lights to reduce glare, dimming lights to get the right amount of light, and turning off lights when not needed. Look at the images below. See the intruder standing in the first picture? In the second image, the photographer is covering the light with his hand, as a properly protected light would do. Now do you see the intruder standing in the pathway? More light does not make us safer! Smarter use of light does!
