Seat 3 Candidates:


Arun Iyampillai & Henry Skip White

Lois Paritsky, Seat 1 unopposed, will give welcoming remarks. Then, in alphabetical order, the candidates for Seat 3 will each provide a three-minute introduction and summary of the issues they think voters should take into consideration.

Next, candidates for Seat 3 will be given three minutes to respond to each of the following questions:

- 1. What are the two greatest challenges you see facing the town of Ponce Inlet in the next one to three years that you will address if elected? Please include why they are important and how you plan to address them.
- 2. In late 2022 two hurricanes inflicted major damage to the dunes, beaches, jetty and several beachfront residences. What initiatives would you look to pursue, both short term and long term, in connection with beach restoration and maintenance?

Finally, the contenders for Seat 3 will answer questions from the audience. Two minutes will be provided for each candidate to answer. Audience questions must be submitted at the door using the forms provided before the event begins. Each question must be signed by the person submitting it. Questions will be directed to the candidates as requested. Candidates will then be given two minutes for closing remarks.



Following the formal session, voters will have the chance to meet the candidates and ask them questions while also enjoying some light refreshments.


Live Streaming of the Candidates Forum

Together, we emerged from the back-to-back hurricanes of 2022 with a renewed determination and focus on resiliency and infrastructure. The Council and our dedicated staff will continue to concentrate our efforts on these important goals and build upon all that has already been accomplished. Town Manager Mike Disher is well prepared to facilitate the work in these key areas, given his experience working in and leading our Town's Planning and Development Department.

Discuss the skills and leadership qualities that you bring to the table that would make you the better candidate for this position.

1. Knowledge:

As a Veterinarian I could not ask my patient what is wrong with him/her. I had to figure out what was wrong and design a treatment plan. As an elected representative I would use the same skill of problem solving those faces the citizens of Ponce Inlet.

2. Experience:

As an owner operator of multiple business enterprises in the State of Florida I performed my fiduciary responsibilities for my clients, employees, and my family. I have experience in budgeting, avoiding wasteful expenses and making my businesses successful. Discuss the skills and leadership qualities that you bring to the table that would make you the better candidate for this position.

An effective leader does three things: Knows the way, shows the way and goes the way. Knowing the right direction for Ponce Inlet is derived from the knowledge you obtain by being involved, asking questions, and interacting with our residents and our elected officials at the County and State level. I have made it a point to not only attend but participate in almost every Council meeting for the last several years in addition to the budget workshops and special meetings that are called from time to time.

Showing the way comes from being involved, often hands on and side by side with neighbors and friends. One example is the work I did to initiate and promote the installation of sand fences on our beach. This effort helped in the accumulation of thousands of cubic feet of sand to protect our precious dunes. I am very passionate about Ponce Inlet and my work on the sand fences is just one example of how deeply I care. I also enjoy my work as the Vice-Chair of our Planning Board where I help my fellow residents that are seeking land use variances.

My track record for "going the way" earned me a position as the Regional President of the second largest Foodservice company in the US. With my strong leadership skills, I helped my southeast region grow to \$8 billion dollar in sales, the largest region within USFoodservice. I know how to set goals and achieve them via hard work, and careful attention to details. Challenges are inevitable and I believe that a positive, can-do attitude inspires others. When decisions are needed, I make them. When mistakes are made, I learn from them and formulate a new plan.

My opponent has not attended any budget meetings and only one council meeting.

The budget process for 2023-2024 has been initiated with the scheduling of the preliminary budget workshop. Please comment on the Capital Improvements and Level of Service proposals and the budgeting challenges the Town faces for the upcoming fiscal year.

I made it a point to attend the June 23, 2023 Budget Meeting. This was an important meeting which provided insight into individual line items so that Council could prioritize them. I am happy to share a few important takeaways:

First, I would like our voters to understand that I place a very high priority on the quality of the services that our residents have come to expect. As such, I evaluate every budget line item to determine its impact on service quality.

That being said, my review of the budget started with the Capital Expenditure (CAPX) items. I gave a greater weight and importance to equipment and supplies that directly impact services.

In terms of staffing expenditure, our residents should know that our Fire and Police Departments account for close to 45% of our total budget. For Fiscal-Year 2023-24, our Police Department is requesting two additional officers.

Given the post-Covid increase in traffic (nearly 1.5 million vehicles per year) coming into town, this is an important public safety issue that I place a high priority on. Whenever one of our officers is out for training, injury, vacation or when one retires, we are too often short staffed. This places a strain on them that I feel we need to alleviate.

I would urge our residents to read the recent Standard of Cover (SOC) document that was prepared by our Fire Department as part of their accreditation process. This critical safety study determined that we need to add one more Firefighter per shift. This is a life safety issue that I fully support.

Also contained in the proposed budget is the Public Works Storm Pipe Cleaning and Retention Pond Excavation project, an important part of the Ponce Inlet Resilience Program. I participated in all of the resilience meetings we held going back to 2020. We need to be ready for anything mother nature has in store for us. I fully support this line item as well.

Effectively controlling storm water runoff is one of the pieces of the resilience challenge that can be undertaken locally. The town has recently started to address this issue. What elements of this effort do you consider imperative to insure a successful outcome?

This is such an important issue for Ponce Inlet. Knowing how serious the challenges are, I made a point to attend the Vulnerability Assessment Study requested by Council in 2020. Upon completion, the findings were presented on January 20, 2022 and gave rise to our Ponce Inlet Resilience Program.

I would encourage all our of residents who are interested in this topic to read the report. If you would like to obtain a copy, please contact me and I will provide a link.

The program encouraged changes in our Town's Comprehensive Plan and were approved by our Town Council in June 2023. Once the State approves it, our Town will be able to amend our Land Use and Development Codes (or LUDC) and other Town Codes in support of our resiliency goals.

In answer to the question, here are some specific elements that should be addressed:

Storm water Pipe Clean out – A line item for this has been proposed for the 2023-24 budget. Whenever these pipes are clogged from debris (even partially) it reduces their capacity.

Retention Area Excavation: Six key retention areas have been identified which require evaluation and possible removal of excessive organic buildup from the sides and bottoms, which reduce their retention capacity. These areas are in the vicinity of Oceanside Village (Michael Lane), Bay Harbour, Beach Street, Inlet Point (north), (Jennifer Circle – south) Inlet Point (south) to Kelley Bea Circle (new area).

One more important aspect involved changes to our Comprehensive Plan and LUDC that would encourage resilient construction. I am aware of several very good examples of resilient homes, and I encourage anyone considering building here to study this issue and adopt the best practices.
