A Moment with the Mayor

One of the most significant responsibilities of the Council is to approve an annual budget that will determine the purchases, projects, maintenance activities, professional services, and new personnel necessary to maintain or enhance the level of services in our town and how they will be funded.

A proposed budget is presented to the Council for review in July of each year and represents the many months of work of our Town Manager, Department Heads, staff, and the Essential Services Advisory Board.

Once the proposed budget is presented to Council, the members of Town Council and the public have opportunities at budget workshops, special meetings, and Town Council meetings to discuss the operational needs and levels of service.

Discussions at these public meetings help the Council as it moves forward in this annual millage rate and budget adoption process. Below is the power point slide presentation from our August 24, 2023, Town Hall meeting, where I provided an overview of the budget process. On September 21, 2023, the Town Council approved a 6.2779 millage rate and adopted our budget, which begins on October 1, 2023, and ends on September 30, 2024.

Budgeting Process

Each and every year, your town government is responsible for presenting a budget to the Town Council. The budget serves as a financial plan for the coming year and is intended to support the town's operations and meet the goals set forth by the council. Each of our department heads is responsible for maintaining and working toward improving the level of service that our residents have come to expect and rely upon.

I would like to take this opportunity to present a brief overview of the budget process so that everyone can better understand all the steps that take place between the time the work begins each year and the time Council adopts the final millage rate and approves the annual budget.



Directly related to our work on the budget are our property taxes. I know that my neighbors, friends, and relatives don't like paying taxes. You probably don't like paying for them either. But, as our Volusia County Property Appraiser, Larry Bartlett, points out, taxes are the cost of civilization. I will circle back to our property appraiser in just

a moment, but for now, I think we can all agree that when it comes to paying taxes, everyone needs to pay their fair share, and nobody wants to pay more than they need to.

As applied to Ponce Inlet, our property taxes fund approximately 10 different departments and categories of expenses. Close to seventy-six percent of the budget is allocated to the top five departments you see on this list above.

Town Manager & Department Heads

















Each of our departments is led by a department head. Pictured here from left to right are Town Manager Mike Disher, Public Safety Director and Fire Chief Dan Scales, Police Chief Jeff Glazier, Public Works Director Fred Griffith, Cultural Services Manager Jackie French, Finance Director Kim McCall, Town Clerk and HR Director Kim Cherbano, and IT Director Randy Okum.

The budget process begins early in the calendar year, when each department head provides our town manager with an assessment of the needs of their department. These individuals are all experienced leaders who work day in and day out in service to our residents. This preliminary information allows the Town Manager to begin compiling a proposed budget for presentation to the Council.

Once the outline of a preliminary budget is ready for early review, the process of council and citizen engagement and involvement begins. Next, let's walk through several of those steps and review the timeline.

Public Meeting #1 <u>Essential Service Board</u>

March 2nd, 2023

Capital purchase requests in excess of \$50,000 are reviewed by this advisory board (made up of residents) and discussed at a public meeting.

All capital purchases in excess of \$50,000 are subject to a hearing and a vote at the Essential Services Advisory Board, or ESB. This board, made up of residents with expertise in each of the five disciplines, conducts a public hearing during which each item is presented, reviewed, debated, and finally voted on.

The ESB sends a recommendation to the Council, where a determination is made to include or exclude specific line items in the final budget.

A series of budget workshops are then scheduled. These public meetings are always noticed, and our residents are invited to attend. During these preliminary meetings, the council will discuss expense and revenue projections, along with priorities for equipment, projects, and staffing levels, and debate the merits of each item. The first such meeting this year took place on June 23.

A second budget workshop was held on July 18th. This meeting provided another opportunity to evaluate specific line items and discuss the overall level of service to provide, along with its associated millage rate. Again, this was a publicly noticed meeting where our residents were invited and encouraged to attend and participate.

On July 20th, the council set a proposed millage rate based on what we projected should be included in the proposed budget. This rate represents a "ceiling," the highest millage rate that the Council can adopt while leaving open the possibility of a lower rate being set at an upcoming meeting.

On September 6th, the council held another public meeting to finalize the budget and set the tentative millage rate. Once agreed upon, the item was included in the agenda for the September 21st Council meeting.

During the September 21st Council meeting, the final budget was adopted, and the millage rate for Fiscal Year 2023-2024 was voted on.

In summary, there are approximately six opportunities for our residents to be heard and engage with the Town when it comes to formulating the budget. By law as well as design, it is a very open process where resident input is welcome and encouraged.

Residents can attend and ask questions as to why certain items are included or excluded from the budget. Our Town Manager and our department heads are there to address each question that pertains to their department's share of the budget. Residents may have also reached out to our staff and council members via phone or email to ask questions and express their opinions.





Now that we hopefully have a better understanding of the town's end of the work, let's circle back to Larry Bartlett, Volusia County's property appraiser.

The property appraiser's primary job is to calculate the taxable value of our property. The taxable value, multiplied by the millage rate, determines the amount of "ad valorem" revenue, or revenue from the value of our real estate, that the Town receives each year. Approximately 79% of Ponce Inlet's revenue comes from Ad Valorem taxes. Because each municipality is different in terms of its available revenue streams, the ratio of homes to businesses, and the percentage of homesteaded properties, comparing millage rates between municipalities is rarely an applesto-apples comparison.




How is Taxable Value Calculated?

Just Value	\$580,000	Property's Market Value
- Accumulated SOH	- \$200,000	Accumulated difference between Market Value and Assessed Value is the Save Our Homes Benefit
= Assessed Value	= \$380,000	Market Value minus Accumulated SOH
- Exemptions	- \$50,000	Homestead can result in exempting up to \$50,000 o home's assessed value
= Taxable Value	= \$330,000	Assessed Value minus Exemptions


This slide above explains how the taxable value is calculated. Starting with the just value, which is derived from the market value, the first reduction is based on the accumulated Save Our Homes (or SOH) benefit. SOH dates back to an amendment to the Florida Constitution in 1995. It limits the annual increase in the assessed value of homesteaded properties to 3% or the change in the National Consumer Price Index (CPI), whichever is less. After this adjustment, we arrive at the Assessed Value.

Finally, homesteaded properties receive an additional fifty-thousand-dollar exemption. The remaining amount is the taxable value.

Now that we understand how our Property Appraiser goes about his work, let's apply this to some example properties in Ponce Inlet.



Many of you are probably familiar with the term "median value." At this point, half the homes in Ponce Inlet have a higher taxable value, and half are lower.





A homesteaded property with a taxable value of \$500,000 will have appreciated almost \$100,000 over the same period of time, with a tax increase this year of about \$667.00 based upon a 6.5 millage rate.

The median taxable value of a homesteaded single-family property in our Town is approximately \$328,000. Using this as a reference point, let's apply a tentative millage rate of 6.5 and see what the results are. As most of you know, Ponce Inlet accounts for approximately one-third of your total tax bill.





At a 6.5-millage rate, taxes would increase \$463 per year compared to 2022. Last year, the council voted to reduce taxes, and the same home received a \$135 reduction. If we combine the two years into a single composite rate, the two-year difference in taxes between 2021 and 2023 comes out to approximately \$164.00 per year for each of the last two years.

A homesteaded property with an assessed value of approximately one million dollars will see a tax increase this year of approximately \$1,335 under this scenario but will have appreciated almost \$200,000 in the last two years.



Several extraordinary events had an impact on our reserve levels and the 2023 budget calculations. First, we sustained approximately \$850,000 worth of stormrelated cleanup following Hurricanes Ian and Nicole. We have already received a portion of that back from FEMA and insurance, but the exact timeline for the rest remains uncertain. Second, the town was involved in a legal proceeding, and although we ultimately prevailed, the cost came to approximately \$500,000. State and federal mandates also increased our wage and retirement costs. These items were on top of the inflationary pressures we are faced with on almost everything we purchase. The Town is not exempt from the same cost increases that our residents are subjected to.

The final budget this year was voted on at the September 21st council meeting. It provided for the safety, well-being, high-quality service levels, and expectations of our community. Our residents have chosen to make Ponce Inlet their home for a number of very good reasons. I believe that the Council has an obligation to meet their expectations and to do so with a responsible and well-thought-out budget.

I hope I have helped you understand the process just a little better, and I look forward to seeing you at the next budget meeting. Thank you.



COUNTY CORNER

Hello everyone. It is that time again for an update from your County Councilman, Matt Reinhart. As I have done in the past two updates, I will start off by giving you an update with regards to our beaches. Since the last newsletter, the following has taken place:

- The trap bag deployment that was implemented several months ago has reached over 46,000 linear feet. That has obviously increased from the 34,670 linear feet reported in the last newsletter.
- In my last newsletter, I reported that the County had already removed over 11,950 cubic yards of debris from our beaches. That number is currently over 13,000 cubic yards.
- Many have asked about some of the walkovers and when they will be fully repaired. I can tell you that some of them have been a bit challenging since poles need to be drilled down to support those walkovers. They must be sunk down a considerable amount, and to do that, the tides must work with us. Recently, that has not been happening. Other walkovers have ADA issues, and that work must be subcontracted out. We anticipate more of this to be accomplished during the winter months.
- We have a couple of sand replacement projects in the works as well. The first is a dredging project for the intracoastal waterway. This will help produce about 700,000 cubic yards of beach compatible sand. It will be staged in the Ponce Inlet area to be ultimately placed in the most vulnerable areas needed. Another sand replenishment project is that of obtaining approximately 550,000 cubic yards of



beach-compatible sand from Rattlesnake Island, which is located near the Inlet.

The plan for the U.S. Department of Housing and Urban Development (HUD) grant that was awarded to Volusia County in the amount of \$328.9 million has been approved by Volusia County Council. Therefore, the next step is to review the applications being received by those to whom the grant is applicable. I mentioned in the last newsletter that I am currently working on a project to install 9-1-1 call boxes at our county-operated parks. The idea is to start with our coastal parks, as they are already due for necessary repairs due to last year's storms. We are in the solicitation phase of obtaining bids for this project. There may even be grants available for the purchase of this equipment. If they prove to be helpful, which I anticipate they will be, I plan to see if the program can be expanded to other county parks. I will keep you posted. I recently had a meeting with Dr. Duane DeFreese, Ph.D. His area of expertise is that of coastal conservation, sustainability, water quality remediation, climate change, sea level rise, and water resources.

The purpose of this meeting was to see what we could do to assist with the improvement of our water quality in the IRL (Indian River Lagoon). The growing of mangroves is a proven method. I wanted to see if it was possible to grow the mangroves off-site and then replant them in the IRL. At the end of the conversation, we agreed this could be done. Lidentified that I would like to see if we could teach our inmate population how to perform both functions (planting and growing and then replanting). I am now seeking appropriations from the State of Florida to purchase two greenhouses to be placed on Corrections property. The appropriations process is scheduled to be heard by our local state delegation next month. If approved, we would be awarded those appropriations for next year's budget. This plan not only helps our waterways but also assists our neighboring county of Brevard and Palm Beach County stretching 156 miles. This also helps teach our inmates a new trade and the importance of conserving our waterways.

task. Our focus needs to be staffing the actual institutions for staff and inmate safety, as well as the safety of our citizens. I will keep this program on the drawing board, though, and if I am fortunate enough to be re-elected in November 2024, we can revisit.

Lastly, we just approved our annual budget for 2023–24. The amount was almost \$1.4 billion in both operating and non-operating costs. For more information, please go to FY 2023–24 Budget Information (volusia.org)

From the Town Manager, Mike Disher

Time flies when you enjoy what you do! I was recently surprised to realize that as of November 2023, I will have worked for the Town a total of 11 years. I started as the Senior Planner in the Planning and Development Department, then became the Assistant Director in 2018, and finally the Director in 2021. I can say that when I first began working here, I never imagined that I would be in this role today. But last summer, when the previous Town Manager, Jeaneen Witt, asked if I would be willing to serve as the Interim Town Manager after her resignation, I couldn't say no.

It is even harder for me to believe that it has now been a whole year since the Town Council appointed me as the Interim Manager. Officially being hired as the Town Manager last April was an incredible honor for me personally and professionally. It has been especially rewarding to work closely with the Town Council, Boards, department heads, and residents. I want to express my gratitude and appreciation for your encouragement and support of me and the Town staff, because none of us would be here without you.

We've been through and accomplished a lot over the past year, including repairs and recovery from two hurricanes; cleaning all storm drainage pipes in the south half of town; completion of improvements to Elbers Park, Pollard Park, and Town Hall; adopting a contract with our local Fire Union; initiating the Watershed Master Plan to improve the Town's flood insurance rating; adopting resilience policies recommended by the 2022 Vulnerability Assessment; finishing the Ponce de Leon septic-to-sewer project; updating the



town's special event co-sponsorship ordinance; maintaining Police Department accreditation for the 15th consecutive year; and celebrating the Town's 60th Anniversary!

The Fiscal Year 2023/2024 Budget

On September 21, the Town Council approved the final budget for fiscal year 23/24. This budget is the result of several months of work based on guidance from the Council and valuable input from the Essential Services Advisory Board (ESAB), all eight departments, and the public over the course of five public meetings and workshops. It is designed to meet or exceed the Town's current level of service to our residents, continue necessary maintenance activities in the wake of last year's hurricanes, and ensure adequate reserves.

The FY 23/24 budget includes the top priorities of the Council, including new staff positions for emergency responders and much needed maintenance of our stormwater drainage system. Some highlights of this budget are: three new firefighter positions, two police officer positions, and one public works position, all to be hired at mid-year; cleaning the storm drainage pipes in the north half of town; creation of an Adaptation Action Plan, which is the next step in the town's resiliency planning efforts; excavating the Town's retention ponds to remove muck deposits; installing one-way backflow valves in storm drains on low-lying streets; and purchasing a new emergency power generator for the Community Center.

In a few months, the budget process will begin again for FY 24/25. The first opportunity for the public to participate is the Essential Services Advisory Board (ESAB) meeting in March. At this meeting, the ESAB will be asked to review and help prioritize budget proposals related to the departments of police, fire, and public works. Balancing the Town's operational needs, service levels, and quality of life are all considerations in the budget process where public input is not only welcome, but vital.

Accreditation

An accreditation program has long been recognized as a means of maintaining the highest standards of professionalism. Accreditation is the certification by an independent reviewing authority that an entity has met specific requirements and prescribed standards. Law enforcement agencies can attain accredited status through the Commission for Florida Law Enforcement Accreditation, Inc.

On August 15, 2023, assessors from across Florida arrived in Ponce Inlet to conduct a three-day review of the Ponce Inlet Police Department (PIPD) policies and procedures. They reviewed files, proofs of compliance, interviewed officers, conducted ride-alongs, and inspected equipment. The PIPD was responsible for complying with over 200 standards to achieve re-accreditation.

On October 5, 2023, Town Manager Mike Disher, Police Chief Jeff Glazier, Accreditation Manager Gina Manchester, and Lt. Corey Mead traveled to Fort Myers, Florida to receive their fifth re-accreditation certificate also known as the Excelsior Award. This is a rare achievement that demonstrates exceptional commitment to the Florida accreditation program. The Excelsior Recognition program is the highest level of achievement a criminal justice agency can receive from the Commission for Florida Law Enforcement Accreditation.

He holds a BA Degree in Organizational Management and is a graduate of the fouryear Executive Fire Officer Program at the National Fire Academy. It is with great enthusiasm that he is returning to Volusia County to continue his public safety career Mr. Landreville was the top finalist from over a dozen candidates, many from out of the county and state. The interview process was very rigorous, with each candidate required to complete a questionnaire, along with an "in-basket" exercise that presented the candidates with a wide range of situational challenges. The comprehensive interview process allowed us to evaluate potential hires in a wide range of performance areas, including their written, verbal, and prioritization skills. The tentative start date for Mr. Landreville will be in mid-November. We are very excited to welcome Joe to the department and look forward to his

contribution to our organization and the community.

Accreditation Update

In September, the fire department received the final version of the Strategic Plan, facilitated by the Center for Public Safety Excellence (CPSE). The strategic plan is the second step in a three-part process for department accreditation through the CPSE. The third part is the self-assessment manual, which is slated to commence this fiscal year. You can view the strategic plan by selecting the link to the fire department page on the Town's website.

New Equipment

The fire department will soon be deploying our new cardiac monitors and defibrillators. The new equipment represents the latest in pre-hospital cardiac care, replacing the previous units that were over a decade old. The new units also provide standardization with other EMS departments and hospitals, allowing seamless sharing of information and the transfer of patient care. The new monitors and defibrillators will significantly enhance the level of care provided by the Ponce Inlet Fire Department.

From Public Works Manager, Fred Griffith...



Our Public Works Department crews continue to stand ready to protect our Town from future flooding. The recent 5"-6" rainfall during the highly intense storm this past month was contained very well within our existing storm water pipes, exfiltration systems, and retention ponds.

Stormwater System Cleaning

In April and May of this year, we had 50% of the storm pipe systems thoroughly flushed and cleaned. We are in the process of getting the remaining 50% of the storm pipe system cleaned later this calendar year. Public Works crews also this year constructed improvements to many of our existing stormwater pipe inlets and outfalls. This past month, the County came through for us, after our urging and encouragement, to construct swales along the western side of S. Atlantic Avenue just north of Beach Street to reduce the amount of stormwater run-off from this roadway. We will be asking them to do more of the same next calendar year, just to the north near the Glenview Avenue area.

New Pumps

We recently received two new pumps, a 3" pump and a trailer-mounted 4" stormwater pump, shown in the picture being tested at the Beach Street retention pond. Later this year, we are planning for additional stormwater improvements along Old Carriage, Anchor Drive, and at the west end of Beach Street, including the desilting of several Town-maintained retention areas on Beach Street and Inlet Point Boulevard.

Our thoughts are with the victims of Hurricane Idalia, which struck the northern Florida Gulf Coast in late August as a strong category 4, but better than our thoughts, our deeds are helping in material ways. Our club is in Florida Lions Multiple District 35-O, and our district disaster team, of which I am a member, received a generous \$10,000 grant from the district. Many of the supplies we purchased with the grant funds were delivered to a firehouse in Yankeetown to be distributed to residents who needed them.

Included were large shovels for mucking out, squeegees on long handles, push brooms, cleaning and mildew removal chemicals, gloves, hand wipes, "blessing bags" with personal hygiene items, etc. Blessing bag supplies were donated by numerous clubs in the district late last year and were then packed into gallon-size plastic bags by the teenage Lions called Leos.

District 35-O also received \$45,000 from our international charity, Lions Clubs International Foundation (LCIF), which was specifically to help recover from Hurricanes Ian and Nicole. The disaster team decided the dollars would make an impact on the most people by renovating a community center in Davenport, which is on the west side of the state and suffered a lot of damage. Their community center serves

Davenport in ways that are very similar to the way our community center (PICC) serves Ponce Inlet. The Davenport Center is the meeting place for numerous clubs (including the Lions Club), community activities, a church, and a community swimming pool. The Davenport Center is now in use again after significant repairs, so we will be applying for a new grant as new needs are identified. Unfortunately, we never run out of need.

Lions Jim Martin, Dan Snyder, Shirley Okhovatian, Charlie Burge, and his wife, Anna, provided the grill and sales services. This summer, Ponce Inlet Animal Welfare Ruthie, one of the original colony cats who is at least 14 years old now, is looking good again after we thought we were losing her earlier in the year. She has become much more docile and gets along fine with Tiki now after a rough couple of years. Some of the volunteers can pet and brush her, so she is living out her last years peacefully with loving care.



I frequently get calls from people in the community who are concerned about stray kittens and cats, and a kind woman from Las Olas recently called about a little black and white cat that she and her son were seeing as they walked to the beach. We determined he was a male, and he was so friendly and sweet. The son named him Arthur, and they and the colony volunteers started feeding him until he could get to the vet, etc. After a week or so, Terri and Rip were able to get him to the Veterinary Emergency Center in South Daytona, where he was determined to be neutered and

declawed but not microchipped. It is hard to imagine anyone intentionally dumping a declawed cat into the wild. After a lot of expensive and time-consuming care by our wonderful volunteers and Mary Ann, our treasurer, sadly, the little guy was too sick to save.

We need to replenish the coffers after the expensive care for Arthur, so please watch for us to be asking for your help at a fundraiser later this year. If you can help now, please call me, and I will tell you how to donate.

We are now working with some concerned residents who have identified what appears to be a stray mother cat and her kittens. I can arrange for discounted spay/neuter services with shots at the HHS/Redinger Clinic, so we are working out a plan with the help of our wonderful animal control officer, Sgt. Rudd, to trap and sterilize the little family. There is also a Siamese cat that appears to be tame, and we are going to work together to trap and get him/her rehomed. Life with cats is never dull in Ponce Inlet, sadly.

Speaking of the Redinger Clinic, October 16 marked the anniversary of the passing of its founder and PAW's cofounder, Alan Redinger. September 11 was the date PAW's other cofounder, Jo Ellen Basile, passed away. We should always remember and be thankful to them for the service they did for the town and the helpless animals.

As summer comes to an end, the Ponce Inlet Lighthouse begins the new school year by welcoming back students from across the state. Over 1000 summer camp children were able to tour the National Historic Landmark this summer, and large numbers of private, public, and homeschool children will once again learn about the maritime and social history of the Ponce Inlet Lighthouse this fall.

What's Happening from October through December 2023

On October 26th, the Ponce Inlet Lighthouse will once again open its doors to homeschool families from across the state of Florida. With a focus on the Indigenous People of Northeast Florida, over 100 students will interact with six workshops focused on Florida's educational standards. Fall Homeschool Day is one of the premier educational events held annually at the lighthouse. If you are interested in helping out with educational events like this, make sure to contact the lighthouse at Education@ponceinlet.org.

Also, the lighthouse will open its doors to cultural institutions from across the state on November 18th for Indigenous Peoples Heritage Day. One of the most popular events run each year at the lighthouse, visitors will have the opportunity to travel back in time and discover the fascinating

history of the indigenous people who once lived along the Volusia County inland waterways and throughout the local Florida region. Learn about the Timucua and Seminole as you explore the historic light station and participate in interactive workshops, living history demonstrations, and other activities presented by lighthouse staff, volunteers, and representatives from museums and cultural sites located throughout Central Florida.



From 10:30 a.m. until 2:30 p.m. on November 24th, the Ponce Inlet Lighthouse will host Thanksgiving Gifts at the Lighthouse. During this family-oriented event, guests will have the opportunity to make crafts, learn about early lighthouse keepers, and climb the tallest lighthouse in the state of Florida.

The Constance D. Hunter Historic Pacetti Hotel Museum Update

After a lengthy process spanning back to October of 2019, major restoration work has officially begun at the Pacetti Hotel! Those who have been following our progress will know of the many steps involved in this process, including acquiring the building and site, placing it on the National Register

of Historic Places, working with a historic preservation architect to plan out the development of the building, and then obtaining permits and approval for all the work that needs to be done to ensure that the 130+ year-old building remains standing for many years to come.

Some town residents might even have seen construction work near the south side of Sailfish Drive. Currently, different teams are working on different projects inside and outside the structure. While window technicians restore the hotel's many historic windows, others are installing fire suppression lines and equipment outside. Interior ceilings have been uncovered for the first time in over a century.

And of course, our staff is recording and photographing this process as much as possible for the benefit of future generations who would like to learn more about this process. Here at the lighthouse, we are lucky to have a relatively comprehensive overview of the construction and changes that happened here at the light station. The Pacetti Hotel, however, is a different story. Being that it was a private building for nearly all of its life, detailed records of building repairs and modifications were not kept like they were here at the lighthouse. This modern-day restoration is a wonderful opportunity for our staff to be able to learn more about the history of the building by studying whatever is found during this restoration phase of the project.

Volunteer Opportunities

The success of all of the programs provided by the Ponce Inlet Lighthouse relies on the dedication and hard work of our amazing volunteer corps. They are the backbone of the programs department, and we appreciate everything that they do for us. The Preservation Association is always looking for individuals interested in becoming volunteers. Monthly meetings and trainings will be provided for all volunteers, as well as the opportunity to preserve and interpret the history of a National Historic Landmark. Twenty-one years ago, the Lord led our family to the beautiful town of Ponce Inlet. In January 2003, the Tidwell family launched the first church in the history of Ponce Inlet. Ponce Church is a Christian, non-denominational church that is active in obeying the words of Jesus by caring for the orphans and widows, giving food to the hungry, water to the thirsty, clothing, healing the sick, visiting those in prison, and providing shelter for the homeless. Watering Guidelines

Watering Restrictions

To ensure the efficient use of water for lawn and landscape irrigation, the St. John's River Water Management District has adopted watering restrictions. These restrictions are in effect year-round and apply throughout the District's entire 18-county area.

Rules & Regulations

During Daylight Savings Time the following rules apply:

Daylight Saving Time begins the second Sunday in March and ends the first Sunday in November. Residential irrigation is allowed at odd-numbered addresses from 4 p.m. to 10 a.m. Wednesdays and Saturdays and even-number addresses Thursdays and Sundays.

Business may irrigate from 4 p.m. to 10 a.m. Tuesdays and Fridays.

Restrictions apply to all water sources, including private wells and pumps, ground or surface water, and water from public and private utilities. New plantings may be watered any time for 30 days, then every other day for another 30 days. Keep the store receipt for proof of purchase. Hand watering with a spray nozzle that shuts-off when released is allowed anytime.

During Standard Time watering is allowed only once a week.

These guidelines apply to all areas in Volusia County, including cities:

- Water only when needed, and not between 10 a.m. and 4 p.m.
- Water for no more than one hour per zone, and no more than ¾ inch per zone.
- Restrictions apply to all water sources, including private wells and pumps, ground and surface water, and water from public and private utilities.






Greetings All!
