### Citizen of the Year 2025 Terry Revak



Since becoming a full-time resident of Ponce Inlet, Terry Revack has volunteered her time to continue to make Ponce such a special town.

For eight years, she has served on the Ponce Inlet Community Center (PICC) board, taking on the role of treasurer since 2020. Terry actively organizes volunteers to staff the PICC office, scheduling herself for multiple days each month and stepping in to cover unscheduled shifts to ensure the center remains accessible to residents and visitors alike.

Terry spearheads fundraising efforts, orchestrating events like Soup and Salad, Dinner Shows, and Irish Night. She meticulously plans these events, manages ticket sales, creates decorations, and even bakes to ensure their success.

At the Ponce Inlet Lighthouse, where she has volunteered since 2017, Terry leads engaging tours, supports events, organizes educational materials, and contributes to the outreach program, enriching the community's connection to its history.

Beyond these roles, Terry quietly supports numerous town clubs by designing flyers, creating Excel spreadsheets, crafting signs, and producing decorations, all with her characteristic humility.

## Lifetime Achievement Ed Davis



Ed and Barbara relocated to Ponce Inlet in 1989, settling on the same street as Ayres and Kay Davies, Bill and Edwina Knox, and other key figures who helped found the town and remained active in its affairs. These inspiring neighbors introduced Ed and Barbara to the town's unique character and vibrant community, sparking their passion to contribute. While Barbara's numerous contributions are widely recognized, Ed has also dedicated himself to serving Ponce Inlet in meaningful ways over the years.

From 1996 to 2000, Ed served as president of Citizens for Ponce Inlet and currently holds a position on its board.

When Volusia County assumed control of the beach from local municipalities, they created the Beach Trust Commission to ensure coastal communities had a voice. The town council appointed Ed as Ponce Inlet's representative, and he served from 1994 to 1996. During this challenging period, Ed and fellow commission members tirelessly advocated for responsible beach management.

Ed also served on the Parks, Recreation, and Tree Board for over a decade, from 1997 to 2007. He humorously recalls the board's hands-on work, including designing and clearing trails in the newly established Ponce Preserve. Today's hikers enjoy trails that Ed and other dedicated board members created by pulling vines and clearing brush. Ed continues this work as a member of the Ponce Preservers, also known as the "vine pullers" or "Barb's Army," a group that has logged over 1,000 hours in the past 18 months to maintain Ponce Preserve as a cherished community asset.

Ed actively participated in the Sailfish Drive Scenic Roadway Committee, where he counted and measured trees along Sailfish Drive and helped secure its designation as a Scenic Roadway.

As an original member of the Friends of the Marine Science Center, Ed supported the center's early development and raised funds to ensure its success.

For the past nine years, Ed has served on the Advisory Committee and later the Board of Trustees for the Ponce Inlet Lighthouse, contributing to its preservation and operations.

Over the past 30 years, Ed has intermittently moderated the Citizens for Ponce Inlet Candidates Forum, alongside Don Hampton. While recent forums have been calmer, Ed recalls the lively and sometimes rowdy discussions of the past, which always provided valuable insights.

Behind the scenes, Ed has been a steadfast supporter of Barbara's many town projects, often serving as her reliable "beast of burden." He consistently assists with tasks like planting flowers around town signs, labeling native vegetation with stakes in Ponce Preserve, and leading bicycle and walking tours of historic areas during anniversary celebrations. Ed also played

a key role during the 10 years Barbara directed the Ponce Inlet Arbor Day 5K race. One memorable task was unloading and mixing bags of concrete for Barbara and the garden club to create unique yard stone awards for runners, which he then presented post-race. Though he might have quietly questioned the need for such elaborate awards compared to standard trophies or ribbons, Ed carried on with dedication.

Thank you, Ed, for your ongoing contributions to Ponce Inlet.

## Lifetime Achievement Joe and Judy DiCarlo



Since relocating to Ponce Inlet in 2005, Joe and Judy DiCarlo have passionately served as dedicated volunteers, enriching the community through their tireless efforts. They frequently worked side by side, contributing to a wide array of organizations and events, including the Ponce Inlet Lighthouse, Historic Museum, Garden Club, Veterans Association, and the Citizens for Ponce Inlet Board. Their commitment extended to bringing joy to children through organizing and supporting Easter egg hunts, Halloween festivities, and Christmas celebrations, where they could often be seen engaging with families and fostering community spirit.

Joe diligently served on the Town's Planning Board for over 10 years, actively shaping the community's development with thoughtful decision-making. Simultaneously, Judy devoted herself to the Code Enforcement Board for the same duration, ensuring the town's standards were upheld with fairness and integrity. Their exceptional contributions earned them high recognition: Judy was celebrated as the Citizens for Ponce Inlet's Citizen of the Year in 2018, and Joe received the same honor in 2019, a testament to their profound impact. Since moving to Ponce Inlet with her husband in the early 1980s, Marylou has actively shaped our community. She co-founded the Ponce Inlet Surf Club shortly after arriving. When her son started kindergarten, she began volunteering at Longstreet Elementary School, later serving as an administrative assistant for over 20 years. Parents of Longstreet students fondly recall her problem-solving skills and dedication.

Marylou tackled Ponce Inlet's severe feral cat issue by helping establish the Ponce Inlet Animal Welfare organization. She fed cats at the colony and volunteered at the Redinger Spay/Neuter Clinic from 2015 to 2019. For over a decade, she served on the C4PI Executive Board, often as secretary, and has been an active Garden Club member for more than 10 years. Since 2023, she has removed invasive plants at Ponce Preserve. Marylou has also been a dependable volunteer at every Christmas,

Easter, and Halloween children's event for over a decade and remains a key member of the Ponce Inlet pickleball group.

Though she has not sought recognition, those who have worked alongside Marylou can confirm her 40 years of selfless service have greatly enriched Ponce Inlet. Her contributions make her a deserving recipient of this award.

# A Moment with the Mayor

One of my most important responsibilities is ensuring that our municipality's visioning statement, rooted in the aspirations and priorities of our residents, guides every policy and initiative we undertake. This requires close collaboration with residents, Council members, the Town Manager, and staff to uphold our shared values and implement plans that foster a resilient and sustainable future.

Recognizing that challenges like flooding do not respect municipal boundaries, I actively collaborate with elected officials from neighboring jurisdictions to develop unified strategies that protect and enhance our collective quality of life. By building strong partnerships both within and beyond our municipality, we can address major issues such as flooding more effectively and ensure our community remains resilient and true to its vision.



It has been my privilege to serve as Chair of the Roundtable of Volusia County Elected Officials, which brings together representatives from every municipality in Volusia County, as well as the county itself. In response to significant flooding in recent years, often caused by rapid development, aging drainage infrastructure, and increased rainfall, I led the creation of a dedicated

Subcommittee on Stormwater Mitigation and Flooding. This group is now working with municipal and county partners to develop a comprehensive stormwater action plan that integrates regional solutions and leverages both local and federal resources. Because water flows across city lines and watersheds span multiple jurisdictions, only a regional approach can truly address the interconnected nature of these challenges.

In addition, I have had the opportunity to collaborate with officials statewide through the Florida League of Cities, an invaluable resource for municipal leaders. Recently, I was appointed to the League's new Training and Advisory Committee, which develops and delivers educational programs for city officials. Comprehensive training, especially for newly elected officials, is essential. This committee builds municipal capacity by designing curricula on governance, ethics, budgeting, and disaster preparedness and by advising on best practices to ensure our training remains responsive to evolving municipal challenges.

The establishment and support of collaborative forums, whether through subcommittees of elected officials or organizations like the Florida League of Cities, are indispensable to effective modern governance. By bringing together diverse perspectives and expertise, these partnerships foster innovation and operational efficiency in tackling complex problems.

# COUNTY CORNER

Hello once again, everyone.

This is your Volusia County Councilman, Matt Reinhart, with your next installment of our quarterly newsletter.

## Beach Renourishment Progress

As many of you have observed, the beach renourishment projects are well underway. Halifax Paving trucks are actively moving beach-compatible sand onto the inlet beach. This sand is now settling, and crews have already started placing it at the Sunglow Pier, progressing southward to avoid disturbing newly placed sand. This approach also aligns with sea turtle nesting season requirements set by the Florida Fish and Wildlife Conservation Commission (FWC).

Once the most vulnerable areas are addressed, Halifax Paving will extend north of the Sunglow Pier to other areas of our Volusia County beaches that were most affected by the hurricanes.



To support the next phase of work, the Oceanview Avenue Beach Approach in Ponce Inlet temporarily closed on Thursday, May 29, as Halifax Paving, the contractor hauling sand northward, will use the approach for staging and construction access.

Once hauling operations are complete, Volusia County will begin long-term improvements to the Oceanview Avenue approach. Plans include the construction of a new seawall, enhanced stormwater and parking infrastructure, and a fully ADA-accessible beach ramp. The upgraded approach is expected to reopen by next summer.

The U.S. Army Corps of Engineers (USACE) anticipates completing dredging activities by the end of September, barring any major coastal weather events. Their contract is scheduled to conclude in November, with demobilization likely occurring during October and November.

Following the completion of the initial project, the same dredging company will dredge the shoals of the Intracoastal Waterway to collect an additional 1.7 to 2.2 million cubic yards of sand. This separate project is necessary due to permitting requirements.

Please note that sand can only be placed on private property where owners have provided temporary easements to the County. To check your property's easement status and view your neighbors' participation, please visit [www.volusia.org/sandprojects](http://www.volusia.org/sandprojects).

Following sand placement, dune vegetation will be installed. This dune vegetation was obtained through another grant the County of Volusia applied for.

One last thing I would like to discuss, and that is my "Second Chance Initiative." I have talked extensively about the inmate training programs and job fairs as part of the initiative, and that work continues. However, in the past two years, I have talked about the possibility of starting an inmate farm. At the February 8, 2025, County Council meeting, I made a motion to officially start this program. Within the next 90 days, staff will return with options for the Council to vote on that will bring the farm to fruition. The main reason for waiting this long is due to staffing levels at the jail being extremely low. In fact, two years ago, the Volusia County Division of Corrections had approximately 70-80 vacancies. I am happy to report that we are now at 11 vacancies. Therefore, I believe we are in a better position to initiate the Inmate Farm project. We will probably start with egg-laying chickens and more tower gardens that produce more vegetables.

As your State Senator for District 8, I remain committed to championing the priorities that matter most to our community, from supporting veterans and public safety to strengthening our local economy and protecting Florida's future. The 2025 Legislative Session brought both major wins and unique challenges. While we made significant progress on policy, the session formally extended beyond its original timeline due to continued negotiations on the state budget. While it may have gone on longer than expected, the 2025 Legislative Session has come to an end. During the late hours of June 16th, the Florida Legislature passed the 2025–2026 budget for the State of Florida. This state budget continues to reflect Florida's values of fiscal responsibility, strategic investment, and an unwavering commitment to our people and communities. With a balanced budget of \$115.1 billion, we are funding critical services while growing our reserves, paying down debt, and delivering over \$1.3 billion in meaningful tax relief.

I'm especially proud to have secured \$500,000 in state funding to support the design of a new fire station in the Town of Ponce Inlet. This is exactly the kind of meaningful, community-focused project that deserves our support at the state level. It will enhance public safety and ensure the Town can deliver critical emergency services more efficiently when and where they're needed most.

Another major highlight of this budget comes from the tax package. The Florida Legislature decided to permanently eliminate the business rent tax, the only one of its kind in the country,

helping small businesses reinvest in their employees and communities. We've also expanded permanent sales tax holidays on essential items like back-to-school supplies and permanent year-round sales tax exemptions on items like disaster preparedness goods. These broad-based savings keep Florida affordable for families while keeping our economy competitive.

With education being a priority for many, we committed over \$20.9 billion in Pre-K–12 education funding and \$8.9 billion for higher education; we are continuing Florida's leadership in school choice and academic excellence. We've boosted per-student funding and dedicated over \$1.35 billion to teacher pay raises. I'm especially proud of our funding for school safety, career training, and early autism detection.

As always, Florida remains committed to our veteran and law enforcement communities. I'm proud that this budget includes nearly \$240 million for the Florida Department of Veterans Affairs, supporting critical services and infrastructure like our Veterans' Nursing Homes. We also approved significant pay raises for state law enforcement officers, including a 10–15% salary boost based on tenure. These brave men and women deserve nothing less.

One more important thing to highlight is the head-on approach we are taking when it comes to Florida's debt. While Washington racks up debt, Florida is doing the opposite. We're paying down \$830 million in state debt this year and establishing a \$250 million annual debt reduction program through SB 1906. Combined with \$12.4 billion in reserves, we are ensuring Florida remains resilient in the face of future challenges.

It is important to note that the budget is still pending Governor DeSantis' review and signature, with the potential for vetoes. 
# WORD FROM WASHINGTON

# From the Town Manager, Mike Disher

## Ponce Inlet Election Results

The Town of Ponce Inlet proudly congratulates Mayor (Seat #1) Lois Paritsky, Vice-Mayor (Seat #5) Gary Smith, and Councilmember (Seat #3) Skip White on their unopposed re-election to the Town Council. The Town warmly invites all residents to attend their inauguration ceremony on November 20, 2025, at 2:00 p.m. in the Town Council Chambers. We hope to see everyone there!

## Beach Restoration Project

Volusia County's beach restoration project in Ponce Inlet is well underway, with work focused along the stretch of shoreline between the North Jetty and Sunglow Pier. Throughout May and June, crews have been hauling and placing sand along the coastline to rebuild dunes, repair storm damage, and improve the shoreline's ability to withstand future storms.

Once the sand placement phase is complete later this summer, Volusia County will begin major upgrades to the Oceanview Avenue access point. Planned improvements include a new seawall, enhanced stormwater and parking infrastructure, and a fully ADA-accessible beach ramp. The revitalized access is expected to reopen in time for the 2026 summer season.



We recognize that some may find the construction activity to be inconvenient or annoying at times. However, we try to focus on the positives: 1) that the County persuaded the U.S. Army Corps of Engineers



to deposit the sand on the beach instead of dumping it into the ocean, as was originally planned; 2) that the work is being funded entirely through state and federal grants, rather than local tax dollars; and 3) the sand and subsequent beach vegetation plantings will help our shoreline to withstand future storms.

Though the work may be a temporary disruption, it reflects real progress—protecting our coast, improving access, and ensuring that future generations can continue to enjoy the beauty and safety of our beach.

## The Quint – Why Timing is Everything

In the Spring issue of this newsletter, we proudly introduced the Fire Department's new Quint-75 fire apparatus. This multifunctional firefighting vehicle provides a major enhancement to our emergency response capabilities. With its 75-foot aerial reach, this unit enhances our ability to respond to fires in multi-story buildings, conduct elevated rescues, and provide a safer working environment for our firefighters.

We were very fortunate to find this particular unit, a showroom model, already built and ready for purchase and outfitting. Normally, fire engines like these are built from scratch over a 2-3 year period. They are assembled by hand rather than on an assembly line. The process is more akin to building an airplane rather than a car.

Just as important as the timing was the cost. The Town Council approved the purchase and financing of the Quint last October. Taking advantage of a then-recent drop in interest rates, the Council authorized a seven-year financing arrangement at 3.92% interest, with a principal purchase amount of \$1,263,000, an annual payment of \$209,839.49, and a total close-out payment of \$1,468,876.43. The first payment will be due in November 2025.

Although this sounds like a lot of money, it is a bargain compared to what prices are expected to be in the near future. According to a May 14, 2025 article in the Daytona Beach News-Journal, “Truck prices have doubled in the past decade, with ladder trucks now costing as much as \$2 million each, while fire departments are facing backlogs as long as four years.” This is blamed on industry consolidation, supply chain issues in recent years, skilled labor shortages, and increasing demand nationwide as cities and their service populations grow.



Had the Town Council not acted to purchase the Quint when it did, the Town would likely have faced much higher costs for a unit that would not arrive until 2026 or 2027 at the earliest. Instead, the department was able to take delivery of the Quint in March and finished the final outfitting and training in April. The official “Push-In” dedication

ceremony was held on May 16, 2025. This arrangement has allowed the Town to make use of this impressive vehicle a full six months before the first annual payment is even due!

Thanks to strategic foresight and timely action, the Town has secured a critical public safety asset at a significant savings. This proactive investment ensures our firefighters have the tools they need now—not years from now—to continue protecting lives and property throughout the community.



## Budget Preparation Update

The Town’s budget preparation process for fiscal year 25/26 began in January and will continue through September. There are numerous opportunities for the public to participate in this process. Budget requests from Town staff and the public were presented to the Essential Services Advisory Board and the Cultural Services Board in January and March. The Town Council held its preliminary budget workshop on priorities and levels of service on June 10th. The remaining workshops and hearings with the Town Council for the remainder of the fiscal year are as follows:

- July 15th:** Draft budget workshop
- July 17th:** Proposed Millage Rate Hearing
- September 3rd:** Tentative Millage Rate hearing and 1st reading of Budget Ordinance
- September 18th:** Final Millage Rate hearing and 2nd reading of Budget Ordinance

As always, your input is necessary in order to create a budget that balances the Town's operational needs, level-of-service expectations, and quality of life of the community. We welcome your questions, suggestions, and participation throughout this process. ## From Police Chief Jeff Glazier



As summer picks up and our community enjoys the longer days and warmer weather, your Police Department would like to share some updates regarding traffic enforcement efforts and crime prevention initiatives.



### Traffic Enforcement

Traffic safety is always a top priority. During the summer months and other times with lots of visitors, it becomes especially important to ensure public safety. While radar enforcement remains constant throughout town, additional focus is given to the S. Atlantic and S. Peninsula corridors with the heaviest amounts of traffic. We issue warnings and citations as part of our effort to educate and slow down drivers. Our electronic message board doubles as a radar device and is positioned in different

spots around town where we receive the most complaints.



### Pedestrian Safety

The Police Department continues to participate in the "Best Foot Forward" Program. This program focuses on increasing driver awareness and compliance with yielding to pedestrians in crosswalks. Members of the PIPD dress in civilian clothes and cite drivers who fail to follow the law and yield to pedestrians. Drivers who are cited also receive brochures explaining cross walk rules.

### Crime Prevention

Even in our quiet and close-knit community, it's important to stay vigilant and proactive about safety. Here are some simple steps every resident can take to help prevent crime and keep our town secure:

- Always lock your home doors and windows.
- Always lock your vehicle and never leave valuables, especially guns, in an unoccupied vehicle.
- If you are going away for an extended period, fill out a house watch form with the Ponce Inlet Police Department.
- If you see something suspicious, call 911 so a Ponce Inlet Police Officer can respond quickly.



## Fast Facts About BFF

Proven progress – More drivers are complying with the law and yielding to pedestrians in crosswalks today than they were 10 years ago.



In 2012, only 17% of drivers yielded at BFF crosswalks on roads 35mph or slower. Today, that number has risen to more than 50%.

On roads 40 mph or higher, the driver yield rate has risen from 2% to 45% over the last 10 years.

Best Foot Forward's educational initiatives include community outreach efforts where pedestrian safety messages are presented to communities where locals live and play. The program's message has been presented to more than 120,000 Central Florida residents since 2012.

Central Florida has an established problem with crashes that injure and kill pedestrians. The **Best Foot Forward Coalition** believes the status quo is unacceptable. There is no silver bullet to end pedestrian crashes, but previous successes combined with continued persistence can make a proven difference. Pedestrians' deaths and injuries are not accidents, but crashes that can be prevented.

In 2012, the Best Foot Forward coalition formed with MetroPlan Orlando, the City of Orlando, and Orange County as founding partners. The program has expanded to include Osceola, Seminole, Brevard, Volusia, and Marion Counties and the cities of Apopka, Casselberry, Kissimmee, Longwood, Oakland, St. Cloud, and Winter Park. We are proud to work with more than 35 partners to make Central Florida safer for all road users.

The mission of the Best Foot Forward program is to increase the number of drivers stopping for pedestrians in crosswalks, as Florida law requires, through community **education**, low-cost **engineering**, high-visibility **enforcement**, and data-driven **evaluation**. Our target is zero fatalities and serious injuries, because when it comes to human lives, no other number is acceptable.

### Hurricane Preparedness


Hurricane season runs from **June 1 to November 30**, and preparation is key to protecting your family and property.

**Have a Plan:** Know your evacuation route and have a family communication plan in place.

**Build a Kit:** Stock up on essentials like water, non-perishable food, flashlights, batteries, medications, pet supplies, and important documents.

**Secure Your Property:** Trim trees, secure outdoor items, and make sure your shutters or window protections are in good working order.

**Stay Informed:** Sign up for Town Notification on our website ([ponce-inlet.org](https://ponce-inlet.org)) and emergency alerts at [ponce-inlet.org/191/CodeRed](https://ponce-inlet.org/191/CodeRed), and follow Ponce Inlet Weatherstem on Facebook or at [ponce-inlet.org](https://ponce-inlet.org) for real-time local weather conditions.



### Storm & Fire Safety

Florida's summer thunderstorms bring lightning, high winds, and the risk of power outages and fires. These simple tips can help you and your family stay safe.

**Lightning Awareness:** If you hear thunder, you are close enough to be struck—seek shelter indoors immediately.

**Generator Safety:** Only use generators outdoors and away from windows to avoid carbon monoxide poisoning.

**Grill & Bonfire Safety:** Never leave a grill or outdoor fire unattended, and always dispose of coals and ashes properly.

**Smoke Detectors:** Test them monthly and replace batteries at least once a year.

**Hydrate & Beat the Heat:** During hot summer days, stay cool, drink water, and check on elderly neighbors.

## From Planning and Development Director Darren Lear



### Code Enforcement Workshop

In June, the Code Enforcement team hosted a well-attended and highly engaging workshop designed to address concerns raised by community members about the Town's Code Enforcement program. The event served as a valuable forum to discuss a variety of important topics, including common types of code violations, how the enforcement process works, what to do if you receive a notice, neighborhood-specific concerns, and potential updates to existing regulations.

We were pleased to receive overwhelmingly positive feedback from attendees, many of whom expressed appreciation for the opportunity to learn more about local codes and how to work collaboratively toward maintaining a safe and attractive community. Due to the strong interest, we plan to hold similar workshops in the future. If you would like to be notified about upcoming events or are interested in participating, please let us know.

### Maintenance of Vacant Lots

In recent weeks, we've also seen an increase in inquiries regarding the upkeep of vacant

lots, specifically in relation to overgrown vegetation. It's important to note that maintenance standards apply equally to all properties, whether developed or vacant. Staff routinely monitors these areas for issues such as illegal dumping, unauthorized fill placement, and other code-related concerns. When a violation is observed, the property owner is notified and required to bring the property into compliance within a reasonable timeframe.

### Vegetation Trimming

Beyond general property upkeep, we would like to remind all property owners of their responsibility to manage vegetation in a way that preserves public safety. While many of us take pride in well-maintained yards and beautiful landscaping, overgrown trees, shrubs, and vines can pose hazards when they obstruct sidewalks, roadways, or reduce visibility, especially at intersections. Vegetation that encroaches into the public right-of-way can block traffic signs and signals, create visual barriers for drivers, and force pedestrians to walk into the street, all of which compromise community safety.

With storm season upon us, it's also critical to address potential hazards on your property before severe weather arrives. One commonly overlooked risk is untrimmed or unstable trees. Property owners intending to trim their trees should ensure all yard waste and debris is properly collected and disposed of, particularly if using a contractor. **Contractors doing such work are required to haul away the debris themselves.** Debris left curbside or unattended can quickly become a danger during high winds, potentially turning into airborne projectiles. Timely maintenance can go a long way in reducing risks to both your property and your neighbors.

## Weekend Hours and Contact Information

As always, our Code Enforcement team is available to assist with community concerns six days a week, Monday through Saturday. Should you have any questions, need assistance, or wish to report a concern, we encourage you to reach out. Travis Mincey, one of our dedicated team members, is also available on Saturdays until 4:30 p.m. Travis can be reached by phone at 386-267-6676 (office) or 386-846-5926 (cell). If you see a violation occurring after hours or on Sundays, please report it to the Ponce Inlet Police Department by calling the non-emergency dispatch line at 386-248-1777 (press option #3 for assistance).

## From Public Works Director Steven Wargo



The Public Works Department has made significant progress in stormwater management and continues to move forward with key improvements. Recent swale enhancement projects were successfully completed along Beach Street and at Beacon Point on South Peninsula Drive. The next phase of maintenance will begin on the east side of South Peninsula Drive, starting at Marie Drive and continuing north. This work is scheduled to begin on July 14th and is expected to be completed by July 31st.

In addition to infrastructure upgrades, Public Works has been active in local parks, partnering with dedicated volunteers to remove invasive plant species. Their ongoing efforts are vital to preserving the town's natural beauty. The team also recently installed educational signage in Ponce Preserve highlighting native plants, helping residents and visitors alike discover and appreciate the unique environmental features of Ponce Inlet.

Efforts to improve pedestrian safety are also underway. Public Works has begun evaluating town crosswalks and applying thermoplastic striping and stop bars to enhance visibility and make crossing streets safer for everyone.

As always, we appreciate the community's continued cooperation and support. Together, we can keep Ponce Inlet beautiful, safe, and welcoming for all.



# Know your watering days

	Homes with odd-numbered or no addresses	Homes with even-numbered or no addresses	Nonresidential properties
Daylight Saving Time	Wednesday and Saturday	Thursday and Sunday	Tuesday and Friday
Eastern Standard Time	Saturday	Sunday	Tuesday

## These guidelines apply to all areas in Volusia County, including cities:

- Water only when needed, and not between 10 a.m. and 4 p.m.
- Water for no more than one hour per zone, and no more than ¾ inch per zone.
- Restrictions apply to all water sources, including private wells and pumps, ground and surface water, and water from public and private utilities.



## SPRINKLER HEADS

Sprinkler heads should be aimed to avoid spraying streets, storm drains, or neighboring properties. Misaimed sprinklers spray pavement instead of plants, wasting water and sending it straight to storm drains—useless for your lawn and against conservation goals.

Excess runoff into drains can carry fertilizers or debris, polluting Florida’s coastal waterways and feeding algae blooms.



# WATERING RESTRICTIONS - KNOW YOUR DAYS

The St. John's River Water Management District enforces year-round watering restrictions across its entire 18-county region to promote efficient water use for lawn and landscape irrigation.

## During Daylight Savings Time the following rules apply:

- Daylight Saving Time begins the second Sunday in March and ends the first Sunday in November.
- Watering is allowed ONLY TWICE a week

## During Standard Time the following rules apply:

- Standard time is from November to March
- Watering is allowed ONLY ONCE a week

## OVERWATERING

Overwatering your beachside landscape comes with these specific drawbacks:

- **Shallow Root Systems:** Excess water keeps roots near the surface, making plants less resilient to drought or storms, which Florida gets plenty of.
- **Fungal Growth:** High humidity plus overwatering breeds fungi like root rot or leaf spot, thriving in Florida's warm, wet conditions.
- **Nutrient Leaching:** Sandy coastal soils already drain fast—too much water washes away nutrients before plants can use them.
- **Saltwater Intrusion Risk:** Overwatering near the coast can pull salty groundwater up, stressing plants not built for salinity.

- **Mosquito Breeding:** Standing water from over-irrigation creates perfect spots for mosquitoes, a big deal in Florida.

- **Wasted Water:** Florida's frequent rain often makes extra watering unnecessary, especially with water restrictions in some areas.

- **Soil Erosion:** Sandy beachside soils erode easily with excess runoff, destabilizing your landscape.

- **Weed Explosion:** Wet conditions favor aggressive weeds like crabgrass or dollarweed, common in Florida.

- **Plant Stress:** Native or salt-tolerant species (like sea oats) hate soggy roots and can drown, ruining your coastal vibe.

Beachside Florida's heat, sand, and humidity amplify these issues—less is often more for a healthy landscape.



# Light Trespass and Glare

Light trespass happens when unwanted light spills onto neighboring properties, while glare creates excessive brightness that leads to visual discomfort.

**Shielding:** Direct lights downward or use shields to keep beams focused on the intended area. Opt for fully shielded fixtures—ones where you can't see the bulb from the side or above.

**Aiming:** Position fixtures carefully to prevent light from crossing property lines. For example, a floodlight shining into a neighbor's window or onto the street breaks this rule.

## Improved Visibility

- Reducing glare and light trespass enhances visibility for pedestrians and drivers, especially after dark.

## Enhanced Aesthetics

- Thoughtfully designed lighting highlights a landscape's beauty without contributing to light pollution.

## Dark Sky-Friendly Lighting

- Select lighting products that minimize light pollution by directing light downward, where it's most useful.

## Choose Warmer Light Colors

- Opt for warmer tones (with less blue light) to lessen light pollution's effects on human health and wildlife.

## Minimize Blue-Toned Light

- Blue light can interfere with sleep and other biological processes, so switch to warmer colors whenever possible.

# Garbage & Yard Waste Guidelines for Ponce Inlet Residents

## Pickup Schedule:

- **Garbage:** Collected twice a week on Monday and Thursday.
- **Recycling:** Collected once a week on Tuesday.
- **Yard Waste:** Collected once a week on Wednesday.

## Garbage Container Rules

- **Place All Garbage in Containers:** Put both moist and dry garbage into garbage cans or containers for pickup. Please no loose bags at the curbside.
- **Clean Up Spills:** Pick up and place any spilled garbage—caused by dogs, cats, raccoons, wind, or people—back into cans or containers.
- **Position Containers for Easy Access:** Set garbage cans and containers where collection crews can easily reach them.



## Yard Waste Disposal Tips

- **Pile Yard Waste Neatly:** Stack grass, leaves, small twigs, branches, and yard trimmings on the pavement or next to the street line for easy handling.
- **Keep Streets and Gutters Clear:** Avoid piling yard waste in the street or gutter to prevent it from washing away.

- **Protect Stormwater Drains:** Do not block stormwater drains with yard waste.
- **Cut Large Branches:** Trim large branches into pieces no longer than 4 feet and weighing no more than 40 pounds.

## Yard Waste does NOT include:

- Treated Lumber
- Rocks
- Soil
- Waste generated by tree surgeons or arborist services

**Yard debris co-mingled with non-organic material will not be collected.**

**Contractor Responsibility:** If a contractor is hired for vegetation trimming or removal, they are responsible for removing and disposing of the waste, not the town's waste service.

**Waste Pro** handles all garbage, yard waste, and recycling removal for single-family residences in Ponce Inlet.



# Ponce Inlet Lighthouse and Museum

The Ponce Inlet Lighthouse and Museum's Education Program and its Volunteer Corps haven't taken a summer vacation in at least twenty years, and this year is no different. The stretch of late May through early August sees our volunteers and our programs as busy as they are during the other three seasons, sometimes even busier! New this summer are specific activities aimed at our younger audiences. Open to all visitors, special presentations at the station and our engaging outreach programs at various historic libraries and civic sites around the county bring the station and its rich history to our communities.

Volunteer training is a never-ending feature at the PILH, and since our tours and programs are geared towards making history fun and interesting, our training efforts mirror that. Five Flags Flew Over Florida was a fun and informative special presentation in June around the national celebration of "Flag Day" by Lead Docent John Mann, who also discussed the basics of vexillology, which is the formal study of flags and banners as symbols of identity or nationality.

## What's Happening from August through September

August 9th is National Lighthouse Day and will be observed by a presentation at 1 pm honoring The Twelve National Historic Landmark Lighthouses. Ponce Inlet Lighthouse achieved this major honor in 1998 and was selected as one of the twelve most significant and notable lighthouses built in the country. All told, about 1500 lighthouses were built, with never more than 850 in operation at the same time.

August 16th is Spirit of '45 Day at the Ponce Inlet Lighthouse and will be culminated with a 1pm presentation of Spirit of the Greatest Generation by Lead Docent John Mann. This presentation is a whirlwind view of many of the innovations seen by the Greatest Generation, from war to technological advancements to the Space Race. This presentation is open to the public, included with your general admission price.

Make sure to visit the Constance D. Hunter Historic Pacetti Hotel this summer. As the temperature rises, take time to see Ponce Inlet's newest museum offering. The 5000-square-foot museum is home to wonderful history documenting the earliest settlers of Ponce Inlet.





This spring has been one for the record books. There was so much activity that it's hard to list it all. Here is just a recap of our activities and what's coming up in the next few months.

**Landscaping**—If you've driven by the Community Center, you probably noticed a very different look for us. Thanks to Brian Kopec, our landscape architect and project manager, we have created a world-class look for the property. Of course, it was done in April when we had NO rain, but thanks to a completely reengineered irrigation system, all the plants survived and are now thriving. We also created a very different look for the rear of the property, and it is fast becoming a spot for weddings to be held. With the sun setting behind the bride and groom as they stand beneath one of the wedding arches, it makes for a wonderful, romantic setting. We still have more to do to finish the rear area and make it a place to have parties.

**Farmers Market**—After a few months of operation, the market is going strong. The selection of food and some crafts is diverse and of the highest quality. From a food perspective, we have vendors providing a wide selection of culinary delights, including crab cakes, Italian entrees, Colombian dishes, jams and jellies, local honey, a myriad of cheeses, farm-fresh vegetables and fruits, lobster, French pastries and breads, and biscotti. Craft-wise, we have vendors providing concrete plant pots, outside decor, and wonderful accessories. We will be closing from July through August

and will be reopening the first Sunday in September. So, come out and enjoy some fantastic offerings.

**Rentals**—We are being booked just about every week for either weddings and receptions, birthday parties, baby showers, bridal showers, or celebrations of life. People have found that we are probably the best value in Volusia County. When someone rents the Center, they basically get everything at the Center at their disposal. And remember, Ponce Inlet residents and first responders get a discount! So, come and check us out for your event!

**Emergency Generator**—Thanks to the Town getting a partial grant, an emergency generator was installed in May. In case of a hurricane or other emergency, it will allow the Center to be a staging and respite place for first responders and utility crews. It will also be available to residents to come in, charge their electronic devices, or just have a safe place to take a break.

**Ponce Church**—The Ponce Church, which has been a steady part of our Center for over twenty years, held their last service on June 8th. We will miss Pastor Rick, Nina, and their congregation. **IMPORTANT ANNOUNCEMENT:** Salty Church, based in Ormond Beach, will be establishing a weekly service at the Center every Sunday. This 'satellite' church will draw worshipers from our Town, the Shores, and beyond. It's anticipated that services will start as early as September and in earnest in October.

**Summer Activities**—We are planning to paint or repaint all of our walkways, finish the landscaping, and continue to make investments to make renting the Center even more attractive. So, as you drive or stop by, continue to watch us as we continue to make improvements.

## Memorial Day Ceremony

We had a very moving and special Memorial Day ceremony. This is the one day each year we set aside to acknowledge those service members who made the ultimate sacrifice.

We were privileged to have several local, state, and national officeholders join us for the ceremony. They included US Congressman Cory Mills, State Senator Tom Wright, State Representative Chase Tramont, County Councilmember Matt Reinhart, Sheriff Mike Chitwood, and our guest speaker, County At-Large Councilmember Jake Johansson, who spoke of his decades of military service. Lastly, our Mayor spoke eloquently about the sacrifices made in defense of our freedoms. We had a perfectly timed flyover by the Spruce Creek Gaggle, the Pledge of Allegiance given by the Volusia Young Marines, and a beautifully sung National Anthem and God Bless the USA by Emily McComb.

We were especially pleased to have one of our own founding members, Bill Wester, presented with a Quilt of Valor. It was a total surprise for Bill, and it was extra special as most of his family was able to be in attendance. The quilt he received was magnificent, as the picture shows. ## Memorial Expansion

We are moving forward with the construction of the Walls of Remembrance. The block was laid, and we are now in the process of planning the laying of blank pavers and covering the walls in black granite. This expansion will provide the ability to have up to 600 stainless-steel plaques on the walls and about 900 pavers surrounding the walls. People can also go on the website and make a direct donation to the construction of the walls or even join our association. Anyone who donates \$500 or more will have their name inscribed on a large plaque on one of the walls.

Given the generosity of a couple of residents, we are also establishing a special category of donors—Patrons of the Walls. This designation will be given to individuals or businesses that donate \$10,000 or more to the construction of the walls. Once we have completed the walls, we will create a very special means of acknowledging those donors.

As we move forward with the expansion of the Memorial we are also in the process of replacing faded pavers on the walkway leading to the Memorial with new pavers that should be more resilient to the sun and weather. Our first phase is to replace about 30 of the faded pavers and then continue to replace pavers as necessary.


