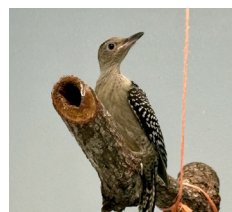

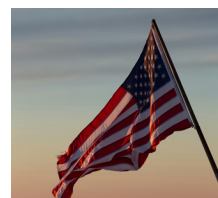

A Moment with the Mayor

It is a privilege to serve in a leadership role, as it allows me to help strengthen our Town's ability to address current challenges and seize future opportunities.

I am honored to serve as Chair of the Florida League of Cities' Utilities, Natural Resources, and Public Works Policy Committee for the 2026 Florida legislative session. Since 1922, the League has represented over 400 municipalities, advocating for home rule and policies that empower local governments to better serve their residents. Through advocacy, collaboration, and leadership, the League ensures municipal perspectives shape state-level decisions.

The Utilities, Natural Resources, and Public Works Committee (UNPW) plays a critical role in developing policy platforms that address key issues such as coastal management, environmental permitting, water quality, and hazardous waste. Consisting of elected officials and professionals from municipalities of all sizes, the committee shapes policy, analyzes legislative trends, and advocates effectively in Tallahassee.

I have served on the UNPW Committee since 2016, progressing from member to Vice-Chair, and now to Chair. These roles have allowed me to engage in vital discussions on diverse policy challenges.

Two pressing issues consistently stand out and will be priorities in the upcoming session: regulating per- and polyfluoroalkyl substances (PFAS) and advancing the One Water framework.

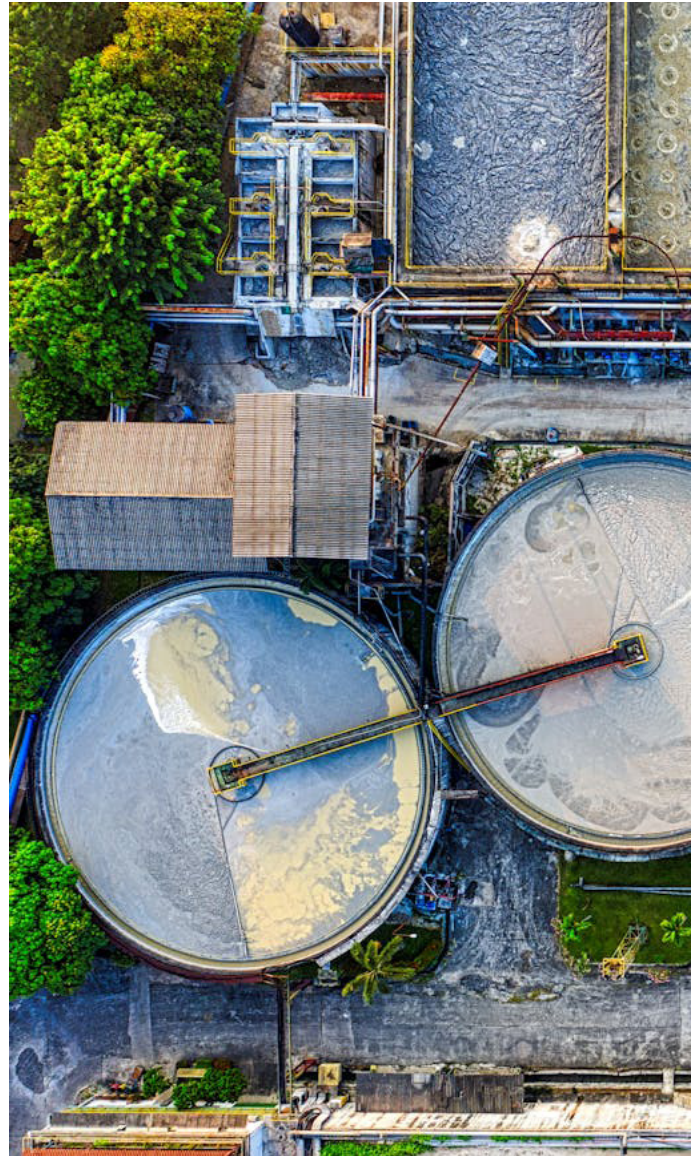
PFAS, often called “forever chemicals,” are man-made compounds that contaminate public water supplies and raise significant public health and environmental concerns. These persistent chemicals, linked to health risks like cancer, thyroid disorders, and reproductive issues, remain in groundwater, food, and consumer products despite some being phased out. The U.S. Environmental Protection Agency (EPA) has set strict, legally enforceable PFAS limits to be met by 2031, requiring costly advanced treatment technologies and infrastructure upgrades. The UNPW Committee's discussions aim to balance technical feasibility, fiscal responsibility, and legal accountability in addressing PFAS.



Equally important is our commitment to the One Water approach, an integrated strategy recognizing the interconnectedness of drinking water, wastewater, and stormwater systems. Expanding the use of reclaimed and recycled water is essential for reducing stress on freshwater supplies, protecting ecosystems, and building resilience against sea-level rise and recurring droughts.

As Chair, I am dedicated to leading our committee in championing solutions that promote sustainable growth, environmental stewardship, and resilient infrastructure. These efforts reinforce the critical role local governments play in building a healthier, safer, and more prosperous Florida for all.

COUNTY CORNER

Hello once again, everyone.

This is your Volusia County Councilman, Matt Reinhart, with your next installment of our quarterly newsletter.



Derelict Vessels

Volusia County is now coordinating the removal of derelict vessels in the St. Johns River basin. Three local companies were selected to participate in the Florida Fish and Wildlife Conservation Commission (FWC) grant program that funds these removals.

Post-Storm Debris Removal Agreement

The County is entering into a proposed interlocal agreement with the Town of Ponce Inlet that transfers responsibility for post-storm debris removal along the portion of County Road 4075/S. Atlantic Avenue within the town's municipal limits. This arrangement will allow for a more coordinated cleanup effort and is in the best interest of the public. The agreement establishes the framework for cooperation between the Town of Ponce Inlet and Volusia County in the removal of disaster debris on this county road.

Stormwater Protections

Volusia County is vulnerable to a wide range of natural hazards, including hurricanes, flooding, tornadoes, and wildfires. These threats can endanger lives, damage property, and disrupt the economy and quality of life for residents and visitors alike.

To address these risks, the County has adopted a **Multi-Jurisdictional Local Mitigation Strategy (LMS)**. This ongoing plan brings together local governments and partners to incorporate hazard mitigation

into day-to-day operations. The LMS sets forth goals and objectives to protect people and property, recommending both micro-level solutions—such as elevation, retrofitting, and acquisitions—and macro-level strategies like growth policies, natural resource protections, and public outreach. The plan is designed as a living document, with regular updates and evaluations to ensure continued effectiveness.

Beach Restoration Project

The sand restoration project at “Rattlesnake Island” is moving forward with full funding from the Florida Inland Navigational District (FIND). Volusia County's costs are limited to design, permitting, transportation, and placement of the sand onto county beaches—ensuring much-needed shoreline improvements at minimal county expense.



Charter Review Committee (CRC) Selections

The County Council has appointed members to serve on the Charter Review Committee, which meets at least once every 10 years as required by the Volusia County Charter. Beginning with its first meeting on **September 3, 2025**, the CRC will have one year to prepare recommendations for potential charter amendments. The County Council will then hold no fewer than three public hearings before placing any proposed amendments on the ballot at the next general election.

Emergency Operations Expansion Funding

Senator Tom Wright presented Volusia County with \$400,000 in state funds to support expansion of the Emergency Operations Center. This funding is part of a larger \$2.5 million project that will add approximately 5,000 square feet of space. The expansion will increase capacity for emergency personnel, improve coordination, and provide flexible space for training and planning outside of emergency activations.

Beach Safety

Following a sharp increase in water rescues caused by rip currents, the Volusia County Coastal Division has expanded public safety messaging. Beach Safety officials strongly urge visitors to swim near lifeguard towers, follow posted warning flags, and avoid venturing into rough surf. Conditions are being closely monitored, and safety messaging will continue to adapt to keep the public informed.

Volusia County Airport

Air service at Daytona Beach International Airport continues to expand.

JetBlue will resume service on **December 4, 2025**, offering two daily nonstop flights to **New York (JFK)** and **Boston (BOS)**.

Breeze Airways recently began new nonstop service to **Canton/Akron (CAK)** on **September 3, 2025**, strengthening connections to the Cleveland metro area.



These additional routes will enhance business and leisure travel, support tourism, and offer residents more convenient options for visiting loved ones.

2025–26 Volusia County Budget

In October, the County Council will adopt the millage rate for the 2025–26 annual budget. The current proposal is to move forward with the rollback rate.

Recently, I had the privilege of joining the Florida Association of State Troopers (FAST) for their annual gathering. It was an honor to speak with them about Senate Bill 138, “The Trenton Stewart Act,” which strengthened penalties for repeat offenders of DUI and boating under the influence. 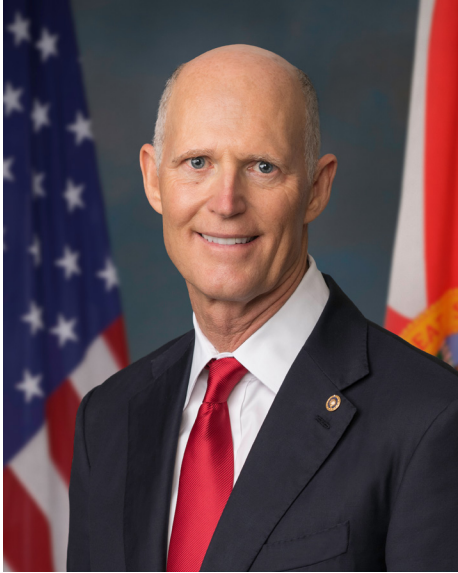

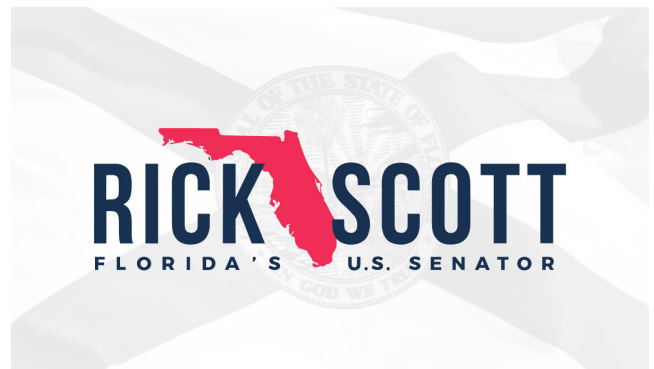

From the Town Manager, Mike Disher

The Fiscal Year 2025/2026 Budget

On September 18, 2025, the Town Council unanimously approved the fiscal year 2025/2026 budget, effective October 1, 2025. This budget ensures the Town maintains or enhances current service levels for residents, continues essential maintenance and drainage improvements following recent hurricanes, and secures adequate operating reserves. The budget reflects months of dedicated work, incorporating recommendations from the Essential Services Advisory Board (ESAB) and Cultural Services Board, guidance from the Town Council, and valuable public input. The process included ten public participation opportunities across board meetings, workshops, and hearings over nine months. The budget prioritizes key Town Council initiatives, including ongoing stormwater drainage enhancements, additional Public Works staff, a feasibility study for fire station upgrades or replacement, resurfacing the Pollard Park tennis court, reconstructing Public Works Building “B,” and repairing park facilities.

The FY 2026/2027 budget process will begin soon, with public participation opportunities at ESAB and Cultural Services Board meetings in January, February, and March. In March, ESAB will review and prioritize budget proposals for police, fire, and public works departments. Public input is welcome and remains vital to balancing operational needs, service levels, and quality of life.



Stormwater Update

King tides and heavy rains are common this time of year, and some areas of Town may experience localized flooding and standing water. During particularly heavy rain, we sometimes receive calls from residents concerned about flooding in their yards. Although their homes are usually unaffected, they worry about the standing water and ask what the Town can do to help. While the Town maintains and improves the stormwater system as a whole, residents can also take steps to protect their own property, as outlined below.

The Stormwater Drainage System

The Town's stormwater infrastructure includes approximately 16,200 linear feet of pipe, swales along major roads, and three retention ponds. Some pipes drain directly to the Halifax River, while others are closed exfiltration systems that temporarily store water until it can soak into the ground. This network is supplemented by public drainage easements on private lots, as well as multiple privately owned retention ponds, pipes, and easements in gated neighborhoods. Swales and depressions on individual lots provide additional storage capacity.



Most residential subdivisions in Ponce Inlet were built before modern stormwater regulations and were designed to handle only limited rainfall. Early systems typically relied on drainage easements on private property and exfiltration pipes, rather than HOA-maintained retention ponds. These systems function well under normal conditions but can be temporarily overwhelmed during heavy downpours and storms. When soils are saturated, as they were after consecutive days of rain this past September, exfiltration pipes reach capacity and cannot absorb additional water. Similarly, pipes draining directly to the Halifax River can fail during extreme high tides when river levels block outflow. In such cases, there is simply nowhere for the water to go until tides recede and the ground has had a chance to dry. Unfortunately, there are no quick fixes—

only steady, ongoing improvements to the system over time.

Stormwater Improvements

Since Hurricane Ian in 2022, the Town has invested more than \$1,000,000 in stormwater improvements. Projects have included cleaning the entire storm-pipe system, purchasing larger pumps, removing 1–2 feet of muck from retention ponds, restoring roadside swales, acquiring land for new ponds, installing one-way storm-drain valves on low-lying streets, and preparing plans for future projects. Work will continue in FY 25/26 with installation of a new exfiltration system on Old Carriage Road, expansion of the stormwater pond at Beach Street, and purchase of low-lying undeveloped property for future pond expansion. The Town is also obtaining cost estimates for the improvements recommended in the 2024 Watershed Master Plan so they can be scheduled and funded. Town staff regularly seeks grants and legislative appropriations to offset costs for taxpayers.

Preparation

Town staff closely monitors weather forecasts and coordinates storm response with neighboring communities. The Public Works Department prepares for storm events by pumping out the three Town-owned retention ponds and providing sandbags to residents. Pumping ponds ahead of time increases capacity and helps upstream properties drain more quickly. This year, the department has also offered sandbags one weekend each month during “Sandbag Saturdays.”

What You Can Do

No one can stop water from flowing downhill, prevent high tides, or make saturated ground hold more water. If your property is at the bottom of a slope, in a flood zone, or contains a drainage

easement, you *will* experience standing water in your yard at some point. However, you can take steps to protect your home before a storm or heavy rainfall:

- **Sandbags:** Pick up sandbags ahead of time from Public Works. The next “Sandbag Saturday” will be October 18, 8 a.m.–12 p.m. at the Public Works facility, 4875 S. Peninsula Drive.

- **Floodproofing:** Talk to Hank Baker, the Town’s Chief Building Official and Floodplain Manager, about options for your home and property.

- **Swales:** Many properties developed since 1990 include swales and depressions designed to hold rainwater and keep it away from homes. Do not fill them in—they are required by the Town’s stormwater regulations.

- **Flood insurance:** Residents in a flood zone receive a 25% discount on flood insurance through the Town’s Class 5 rating in the National Flood Insurance Program’s Community Rating System. Even outside a flood zone, you are eligible for a 10% discount.

- **Storm drains:** Keep drains clear. Don’t pile yard waste near them, and if safe, remove leaves or debris from grates. Remind your landscaper or tree service to do the same.

- **Sprinklers:** Turn off sprinkler systems before a storm to reduce runoff, since saturated soil cannot absorb extra runoff.

Taking these steps, along with the Town’s ongoing improvements, helps us all better manage stormwater during heavy rains.

Service Line Warranty Program

In September 2025, residents received letters from Service Line Warranties of America (SLWA), also known as HomeServ, offering optional warranties for utility leaks on private property, typically not covered by homeowners’ insurance or the Town. The Town Council discussed this program in December 2024 and approved it in May 2025, allowing SLWA to use the

Town logo for informational purposes only. SLWA operates independently, with no affiliation or endorsement from the Town or its utilities department. Your decision to purchase or decline coverage will not affect water service terms, price, or availability. This is an optional service. For emergency alerts, enroll in the Town’s Code Red phone notification system by texting “PonceAlerts” to 99411 or calling the fire department at 386-322-6720. We use this system sparingly, reserving it for critical emergency notifications to avoid unnecessary calls.

From Police Chief Jeff Glazier



The Ponce Inlet Police Department operates 24/7 with 13 full-time officers, three part-time officers, and two civilian administrative staff. There are always a minimum of two officers patrolling the Town at all times. The Police Department has just hired one new officer and has one additional vacancy to fill. The Police Department only hires officers with previous law enforcement experience and exceptional records.

Crime Prevention for the Upcoming Holidays

Even in our quiet and close-knit community, it's important to stay vigilant and proactive about safety. Here are some simple steps every resident can take to help prevent crime and keep you safe.

- Always be aware of your surroundings.
- If you walk or jog or bike while listening to music, turn down the volume so you can hear someone approaching.
- Always lock your home doors and windows.

- Always lock your vehicle and never leave valuables, especially guns, in an unoccupied vehicle.
- If you are going away for an extended period, fill out a house watch form with the Ponce Inlet Police Department.
- Do not leave Amazon or other delivered packages in plain view. Tell a neighbor to hold your packages until you arrive home, or have them shipped to a secure business address.
- If you see something suspicious, call 911 so a Ponce Inlet Police Officer can respond quickly.

The average response time of a Ponce Inlet Police Officer for all calls is under four minutes, and emergency calls are even faster.

- Emergencies: Call 911.
- Non-Emergencies: Call 386-248-7777.

Soliciting in Ponce Inlet

Any solicitor, canvasser, peddler, or any individual engaged in any promotional or commercial activity must hold a valid solicitation permit issued by the Town of Ponce Inlet.

Allowable solicitation hours are Mon-Sat, 9am-6pm. No solicitations shall take place on Sunday. Always ask to see a Town permit from any solicitor selling their services. If they do not have a permit, call the non-emergency number 386-248-7777, and a Ponce Inlet Police Officer will arrive and investigate to see if the solicitor is legitimate.

Permits are not required in connection with solicitation, sales, or similar activity conducted by charitable or non-profit organizations. Permits are also not required for distribution of information of a political nature.

Women's Self-Defense Class

This November, be on the lookout for the next Women's Self-Defense Class at the Ponce Inlet Community Center. This is a safe and fun way to gain confidence and learn the basics of self-defense from Ponce Inlet Police instructors. Participants practice in a controlled environment at their own pace. Space is limited, and spots fill up quickly.

From Public Safety Director and Fire Chief Dan Scales



Key improvements came from adding our Quint fire apparatus, which enhanced firefighting capabilities, and ensuring consistent daily staffing. Equally important, we could not have reached this milestone without the steadfast support of our Town Council and residents, whose dedication to public safety is truly invaluable.

This accomplishment is a reflection of both the hard work of our Fire Rescue team and the trust and backing of our community.

PIFR Training Stronger Than Ever—And Now an ISO Class 2

Ponce Inlet Fire Rescue (PIFR) is proud to share that our Insurance Services Office (ISO) Public Protection Classification (PPC) has improved from a Class 3 to a Class 2. ISO's PPC rating system is a national benchmark that evaluates how well a community is protected by its fire department. This is a big step forward for both our department and our community. The ISO PPC rating is a national standard that measures how well a community is protected by its fire department. Achieving a Class 2 places PIFR among the top tier (about 6%) of fire departments nationwide.

What this means for our community:

Stronger Service— Our rating confirms that our training, equipment, and operations make us more effective and reliable in responding to emergencies.

Positive Community Impact— Insurance companies often use PPC ratings when setting property insurance premiums. Our improved rating may help lower insurance costs for property owners while ensuring strong protection for our residents.



Training Spotlight: A Snapshot of Our Monthly Readiness

Our ISO improvement is directly tied to rigorous, ongoing training. Here's a snapshot from July's training cycle—one example of how we keep skills sharp throughout the year:

Fireground Operations

- Conducted forcible entry and primary search drills at the PIFR training facility.
- Secured a hydrant water supply and deployed a 3-inch line with a Y-connector feeding two 1¾-inch attack lines.

Aerial & Apparatus

- Hands-on aerial operations: setup, stabilization, and safe ladder work.
- Driver/Operator training with a focus on area familiarization and route planning.

Hazardous Materials

- HAZWOPER refresher covering scene size-up, zones, and decontamination.
- Multi-gas detector review: start-up, bump test, alarm thresholds, and interpretation.

EMS Readiness

- Completed assigned Vector Solutions EMS modules to maintain competencies.

Pre-Incident Planning

- Marine Science Center walk-through for emergency familiarization, including access points, suppression features, and life-safety considerations.

Communications

- Portable radio operations refresher: channel plans, emergency traffic, and interoperability.

In 2026, we'll continue this momentum with monthly drills, advanced EMS coursework, officer development, and multi-agency exercises. Our goal is simple: protect life and property with professionalism, skill, and care—every call, every time. Questions? Resiliency Update

On June 19, 2025, the Town began the next step in its resiliency planning efforts by selecting the consulting firm of Brizaga, Inc. to prepare an Adaptation Plan (AP). The AP is a follow-up to the Town's 2022 Vulnerability Assessment (VA) and the 2024 Watershed Master Plan (WMP). The AP is intended to provide the Town with specific adaptation strategies for the most vulnerable areas to strengthen resilience to climate-related hazards. The AP is being funded through a \$50,000 grant from the Florida Department of Environmental Protection (FDEP), through the Resilient Florida grant program. Creation of the AP is one of the Town Council's goals for the Planning Division.

To put it simply, the VA showed what's at risk—identifying neighborhoods, roads, and public facilities most likely to be affected by future sea level rise. The WMP looked at how water moves through the Town, laying the groundwork for better managing stormwater, improving water flow, and reducing flooding.

The AP will determine how to address these

risks by connecting them to implementable solutions and creating Adaptation Action Areas to prioritize investment. The plan will feature high-level conceptual designs, planning-level engineering budgets for priority projects, and identification of potential funding sources. Ultimately, it will create a roadmap to guide investments and increase community resilience over the next 10–30 years.

Find your Flood Information

The Town of Ponce Inlet is improving how residents, builders, and developers access flood information with the launch of a new online flood zone map at <https://ponceinletfl.withforerunner.com>. The map, powered by Forerunner, serves as a centralized hub for critical resources, enabling community members to better understand flood risk, prepare for storms, and strengthen long-term resilience.

Key features of Ponce Inlet's Forerunner public website include:

- **Centralized Resources:** Residents, builders, and developers can now access flood maps, elevation certificates, and property-specific records in one place.
- **Easy-to-Use Tools:** The platform helps community members visualize property-specific flood risk, access preparedness guidance, and find insurance and mitigation resources quickly.
- **Greater Transparency:** By consolidating information into a single portal, the Town is ensuring residents are well-informed and better equipped to respond to hurricanes and flood events.

“Our partnership with Forerunner marks an important step in how we serve our community,” said Hank Baker, Building Official/Floodplain Manager for the Town of Ponce Inlet. “By centralizing floodplain information, we’re making it easier for residents to access the resources they need, while also supporting our team’s ability to manage floodplain inspections and compliance. Forerunner helps us strengthen resilience today and for the future.”

Beyond the public website, Ponce Inlet's floodplain management team is also using

Forerunner's suite of tools—including elevation certificate management, logging resident communication, and tracking inspections—to improve compliance with federal Community Rating System (CRS) standards. These efforts help maintain the Town's Class 5 CRS rating, ensuring cost savings for residents through discounted flood insurance premiums.

Build Responsibly—Use Only Licensed Contractors

If your property is in a special flood hazard area and you are planning substantial improvements to your home—repairs equal to or greater than 50% of your home's market value (not including land value)—then you must meet current Florida Building Code standards and comply with your local floodplain ordinance. Make sure you get a permit before you do any work, and work with a licensed contractor who knows the codes. An Elevation Certificate will be required and may already be on file at Town Hall.



Flood Awareness

The number one weather-related killer in the United States is flash flooding. Eighty percent of flood-related deaths occur as a result of people driving through low-water crossings, walking along the banks of flooded areas, or playing in floodwaters, driving or walking into harm's way. Protecting life and property is the #1 priority. "TURN AROUND, DON'T DROWN."

Code Enforcement Workshops

In June, the Town's Code Enforcement staff hosted a well-attended workshop to address concerns raised by community members. The event provided an opportunity to discuss a variety of important topics, including common types of violations, the code enforcement process, steps to take if you receive a violation notice, neighborhood concerns, and potential updates to code regulations. Feedback from attendees was overwhelmingly positive, and we look forward to hosting similar events in the near future. If you are interested in hosting or participating in upcoming workshops, please let us know.

Hurricane Preparedness

As hurricane season is now well underway, we have begun receiving many calls regarding tree limbs, issues with neighboring homes, new construction sites, and related concerns. Our team has been proactively identifying and addressing potential issues to ensure they are resolved before any storm threats arise. We have also updated our contact lists for HOAs and their management companies, and we have reminded contractors to properly maintain their job sites.

Proposed Code Enforcement Legislation

The Town's Code Compliance Manager (and

Past President of the Florida Association of Code Enforcement) is working with Senator McLain (Ocala) and Representative Partington (Ormond Beach) on proposed legislation related to body cameras. If approved, the legislation would require local code enforcement agencies to establish comprehensive policies and procedures for the proper training and use of body cameras. It would further require agencies to retain body camera data in compliance with public records laws and conduct periodic reviews of actual body camera practices to ensure consistency, accountability, and transparency. Finally, the proposed law would extend the same legal protections to code enforcement officers as it does to law enforcement officers when body cameras are being used. The 2026 legislative session runs from January 13th through March 13th. Most bills signed into law by the governor take effect July 1st at the beginning of the state's fiscal year. Stay tuned for further updates on this topic.

From Public Works Director Steven Wargo



Public Works has several upcoming projects focused on improving both community spaces and vital infrastructure. Planned work includes constructing a new stormwater exfiltration system along Old Carriage Road and expanding the Beach Street retention pond to enhance drainage capacity. Facility upgrades at Town parks are also on the way, with bathroom renovations scheduled at Davies Park and Ponce Preserve, along with the installation of a new fence around the Pollard Park playground to provide added safety and accessibility for families.

Earlier this summer, residents may have noticed temporary lane closures and heavy equipment during two weeks in July and one week in August while crews carried out work on roadside swales. Every effort was made to minimize disruptions and maintain access to homes and side streets. As part of the Town's ongoing commitment to strengthening stormwater infrastructure and neighborhood resilience, additional swale improvements are scheduled to continue in late fall, weather permitting.

To further support residents, Public Works also launched Sandbag Saturday, a monthly event from July through October. These events provide residents with an opportunity to stock up on sandbags ahead of time to help prepare for the peak of hurricane season.

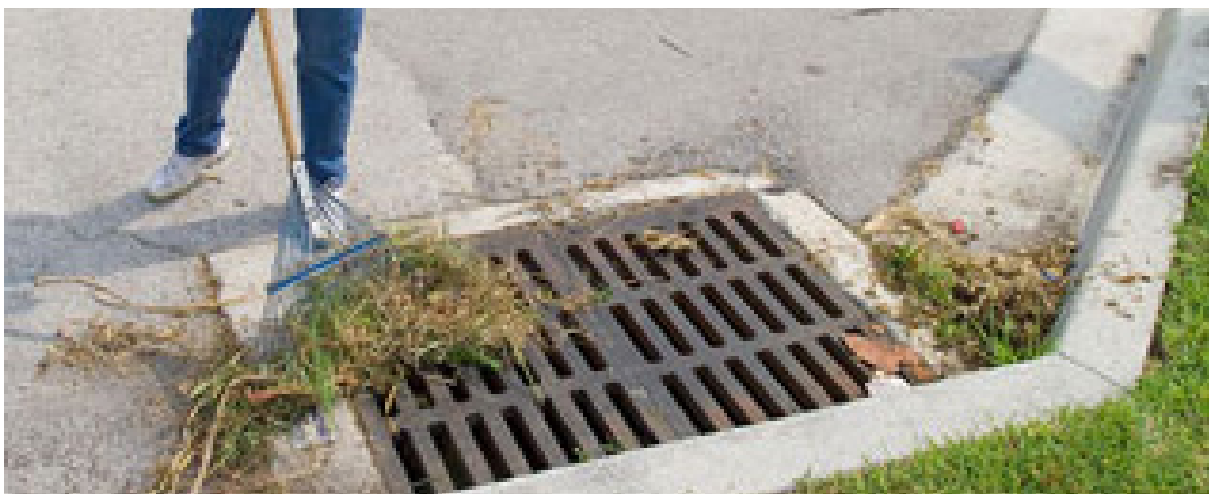


Starting Sunday November 2nd, you may water your lawn only once a week.

Keep Our Storm Drains Clear!

Please avoid blowing grass clippings, leaves, or yard debris into storm drains. Blocked drains increase flooding risks and hinder proper water drainage. If you use a lawn service, please remind them to keep storm drains clear.

- **Bag your yard waste and place it out for pickup on Wednesday mornings.**
- **Keep piles of debris away from storm drains.**
- **Help protect our waterways—storm drains flow directly to canals and the river.**



Garbage & Yard Waste Guidelines for Ponce Inlet Residents

Pickup Schedule:

- **Garbage:** Collected twice a week on Monday and Thursday.
- **Recycling:** Collected once a week on Tuesday.
- **Yard Waste:** Collected once a week on Wednesday.

Garbage Container Rules

- **Place All Garbage in Containers:** Put both moist and dry garbage into garbage cans or containers for pickup. Please no loose bags at the curbside.
- **Clean Up Spills:** Pick up and place any spilled garbage—caused by dogs, cats, raccoons, wind, or people—back into cans or containers.
- **Position Containers for Easy Access:** Set garbage cans and containers where collection crews can easily reach them.



Yard Waste Disposal Tips

- **Pile Yard Waste Neatly:** Stack grass, leaves, small twigs, branches, and yard trimmings on the pavement or next to the street line for easy handling.
- **Keep Streets and Gutters Clear:** Avoid piling yard waste in the street or gutter to prevent it from washing away.

- **Protect Stormwater Drains:** Do not block stormwater drains with yard waste.
- **Cut Large Branches:** Trim large branches into pieces no longer than 4 feet and weighing no more than 40 pounds.

Yard Waste does NOT include:

- Treated Lumber
- Rocks
- Soil
- Waste generated by tree surgeons or arborist services

Yard debris co-mingled with non-organic material will not be collected.

Contractor Responsibility: If a contractor is hired for vegetation trimming or removal, they are responsible for removing and disposing of the waste, not the town's waste service.

Waste Pro handles all garbage, yard waste, and recycling removal for single-family residences in Ponce Inlet.

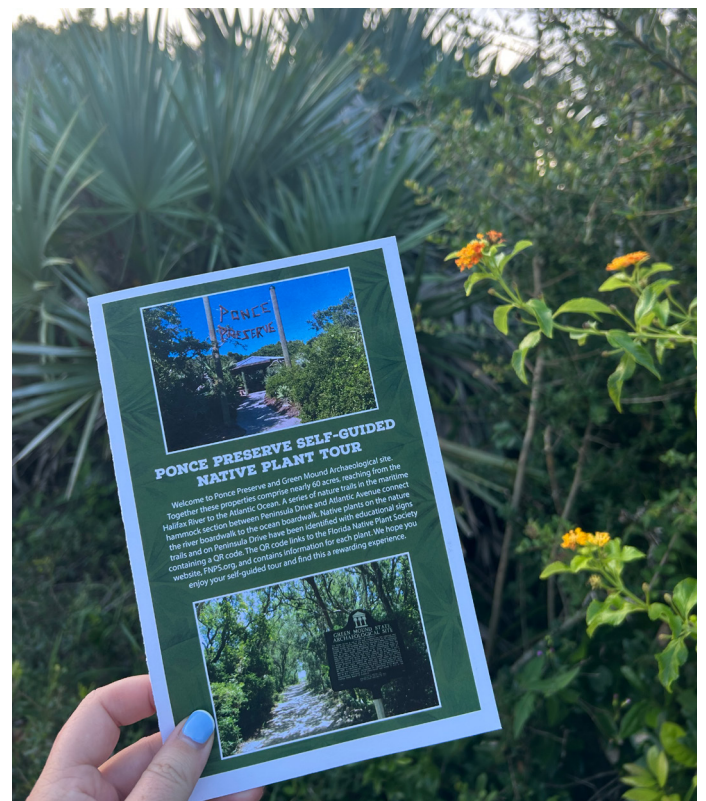


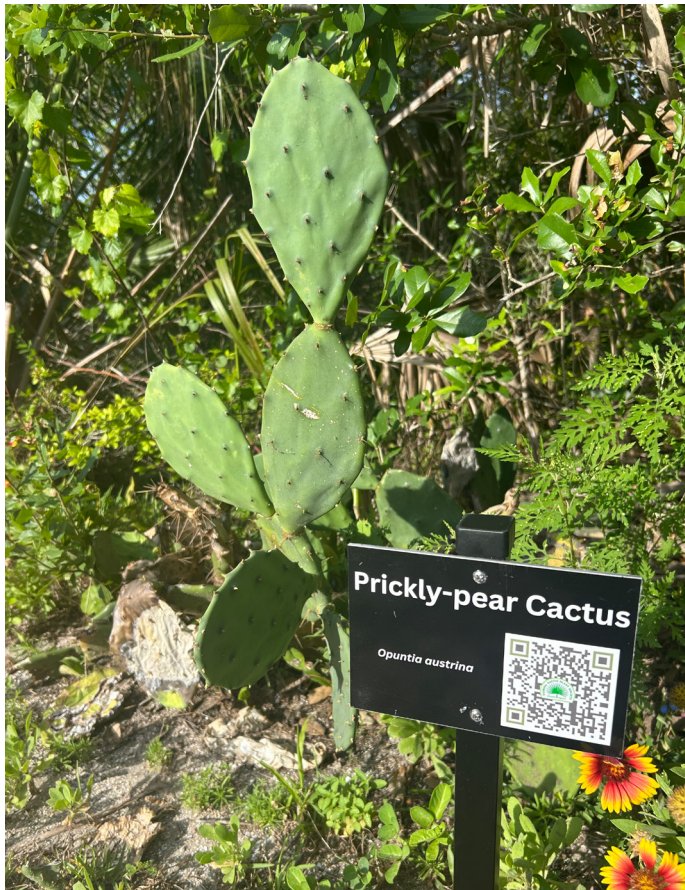

Protecting Our Native Plants: A Community Effort

From the quiet trails to the towering tree canopies, residents often say they love to call this town home for the beauty of our natural surroundings, as well as the connection to community. Protecting that environment doesn't happen on its own. It takes careful stewardship, planning, and countless hours of work by both staff and volunteers making sure our green spaces remain healthy and welcoming.

Over the past few years, the department has placed special focus on protecting native plants. Together with state agencies, staff has introduced air potato beetles as a natural way of controlling the invasive air potato vine, while volunteers have contributed thousands of hours removing invasive plants from Ponce Preserve. Most recently, more than 60 native plants were highlighted along the trails within Ponce Preserve, with the creation of self-guided tour maps made possible through volunteer dedication, donations, and community support. These efforts not only restore balance to our environment but also

In May, the department once again partnered with Young Bear Environmental (YBE Consulting, Inc.) to host another successful volunteer workday, this time at Timucuan Oaks Garden, where volunteers focused on removing the invasive arrowhead vine. Much like last year's air potato removal, this effort was essential to protecting native plants and the tree canopy that define our local ecosystems. Thanks to a passionate volunteer crew, the "Ponce Preservers," a significant portion of the vine was successfully removed from the park's understory. We could not be more grateful for the hard work of this group and our continued partnership with environmental experts. 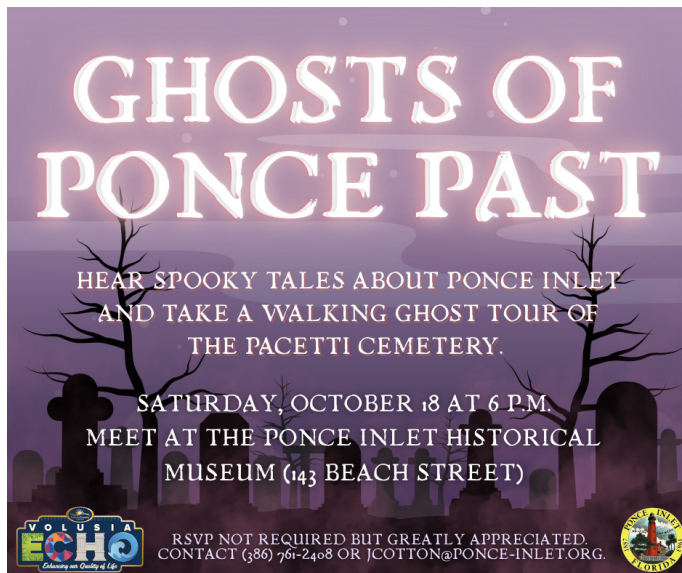

MARINE SCIENCE CENTER BIRD HOSPITAL

The Marine Science Center Bird Hospital in Ponce Inlet cares for approximately 1,100 birds annually. In 2025, we've already treated 725 birds. Our hospital accepts injured native birds 7 days a week from 8 AM to 4 PM. As we wrap up the busy baby bird season, we'd like to highlight one of our patient's journeys.

A juvenile red-bellied woodpecker was admitted after a Ponce Inlet resident found it unable to fly. Our team examined the bird and determined it was a juvenile woodpecker that was lethargic with incomplete feather growth. After receiving supportive care to restore hydration, body condition, and proper feather development, the woodpecker regained its ability to fly and was successfully released back to Ponce Inlet after a short stay.



Red-bellied woodpeckers are distinctive with their barred backs and red head caps. These solitary, territorial birds only typically socialize during mating season. They thrive in wooded areas, nesting in cavities they excavate in dead trees or limbs. As year-round residents, they're often heard making loud calls. You may spot or hear them near your home.

Our dedicated bird staff works tirelessly to intake patients, administer treatments, and manage inquiries. We depend on the public, animal control, beach safety, and volunteers to transport birds to our facility, as our team focuses on caring for hospitalized patients. While we may not always assist directly with rescues, we strive to provide guidance or resources case by case.

I Found a Baby Bird... *Now What?*



How to Rescue Baby Raptors and Waterbirds

Call a wildlife rehabilitator for specific advice before attempting to handle adult birds.

- 1. Note exactly where the bird was found.** Look for a possible nest in a nearby tree. Note if its parents or siblings are in the area. This will be very important for release.
- 2. Prepare a box.** Place a cloth with no frays or loops on the bottom of a cardboard box with holes punched in it or cat/dog carrier, and secure it closed.
- 3. Protect yourself.** Wear thick gloves, if available. Even sick and injured birds may try to stab with their beaks, grasp with their talons (claws), or slap with their wings. Birds may carry diseases or parasites such as lice, ticks, and intestinal parasites.
- 4. Cover the entire bird with a light sheet or towel, including its head.**
- 5. Pick up the bird.** With its wings folded up against its body, pick up the bird by its sides. If necessary, gently restrain the head so it does not bite or peck you. Mind the feet so they do not grab you. Place the bird into the prepared container.
- 6. Warm the bird if it is cold or featherless.** Use a heating pad under half of the box on low, or fill a water bottle with hot water and wrap it with a cloth and place it next to the bird inside the box. Double-check to make sure it does not leak to prevent the animal from becoming wet.
- 7. Secure the box shut.**
- 8. Keep the bird in a dark, quiet place away from drafts.** Do not give food or water. To reduce its stress and habituation, do not handle or talk to the bird. Keep children and pets away.
- 9. Sanitize after contact with the bird.** Wash anything the bird was in contact with including your hands and clothes.
- 10. Contact a wildlife rehabilitator, state wildlife agency, or wildlife veterinarian as soon as possible.** Do not keep the bird longer than necessary. Keep the bird in a container; do not let it loose in your house.
- 11. Get the bird to a wildlife rehabilitator as soon as possible.**

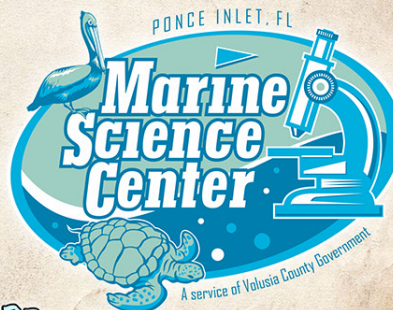

Fall for the Programs Department of the Ponce Inlet Lighthouse means new school groups coming to experience the thrill of climbing the lighthouse, homeschool groups making Florida history a priority, and wonderful onsite educational days that enthrall lighthouse fans new and old.

Summer brought families to the Ponce Inlet Lighthouse, as vacationers flocked to the Daytona area to enjoy the sun and beaches. Thousands of children, temporarily freed from their schoolhouses, enjoyed the summer with camps, outings with families, and, of course, trips to the local libraries to escape the heat and rain.

Thousands of students were able to experience the Ponce Inlet Lighthouse and Constance D. Hunter Historic Pacetti Hotel Museum throughout dozens of summer camps. The dedicated volunteer corps of the lighthouse dispensed the important history of the Ponce Inlet Lighthouse and dodged the Florida heat and weather, while Volusia County children climbed the 203 steps up Florida's tallest lighthouse.

A collaboration with the Marine Science Center allowed a new educational exhibit to take the forefront at the Constance D.

Hunter Historic Pacetti Hotel. Students and guests engaged with a unique offering, Sharks in the Inlet. The newly reopened Marine Science Center loaned a number of artifacts, including taxidermy sharks, while the volunteer corps of the lighthouse engaged visitors with the history of sharks here in Ponce Inlet. While the east coast of Florida remains the highest in volume of shark attacks in the world, the stigma of sharks can easily be dispelled. Students were able to learn about the reasons behind the number of sharks that roam these waters and get a better understanding of the natural habitat of sharks in our area, as well as identify sharks by their teeth. More dates are being added for the display throughout the fall, so make sure to follow the Ponce Inlet Lighthouse on social media for more dates and times.



Each year the Ponce Inlet Lighthouse participates in a series of educational and fun presentations at libraries across Volusia County. This year's theme was all about Lighthouse Crafts. Hundreds of children had the ability to learn about the history of children who lived at the lighthouse throughout history, as well as make exciting kids' crafts.

Did you know that the owners of the Pacetti Hotel Museum also owned the Cincinnati Reds baseball team throughout the 1970s, an era that became known as the "Big Red Machine"? Come and celebrate the 1975 and 1976 back-to-back World Series championships with onsite activities beginning at 10:00am and lasting until 3:00pm. Festivities include historic presentations, artifact demonstrations, children's craft activities, and much more.

Enjoy the sounds of the season as the Daytona Beach Concert Band performs classic holiday tunes and modern favorites. Following the festivities, ring in the holiday season by taking in the sights from the top of Florida's tallest lighthouse and visiting the Historic Pacetti Hotel Museum. All activities are included with the general admission price. Following the concert, the Ponce Inlet Christmas Parade will take place at 2:00pm, making it a fun and festive day throughout the town!

The Constance D. Hunter Historic Pacetti Hotel is always updating and adding new exhibits. On August 22nd, the newest museum in Ponce Inlet celebrated the one-year anniversary of the soft opening. Whether you have seen it multiple times or you have not had the opportunity to visit yet, now is the perfect time, as there are constant changes taking place to add to the expansive history. New artifacts are being added regularly, and guided tours of the building take place often. Make sure to take

a look at the Ponce Inlet Lighthouse and Museum calendar of events for upcoming tours at both the lighthouse and Historic Pacetti Hotel Museum. Your general admission always includes these tours.

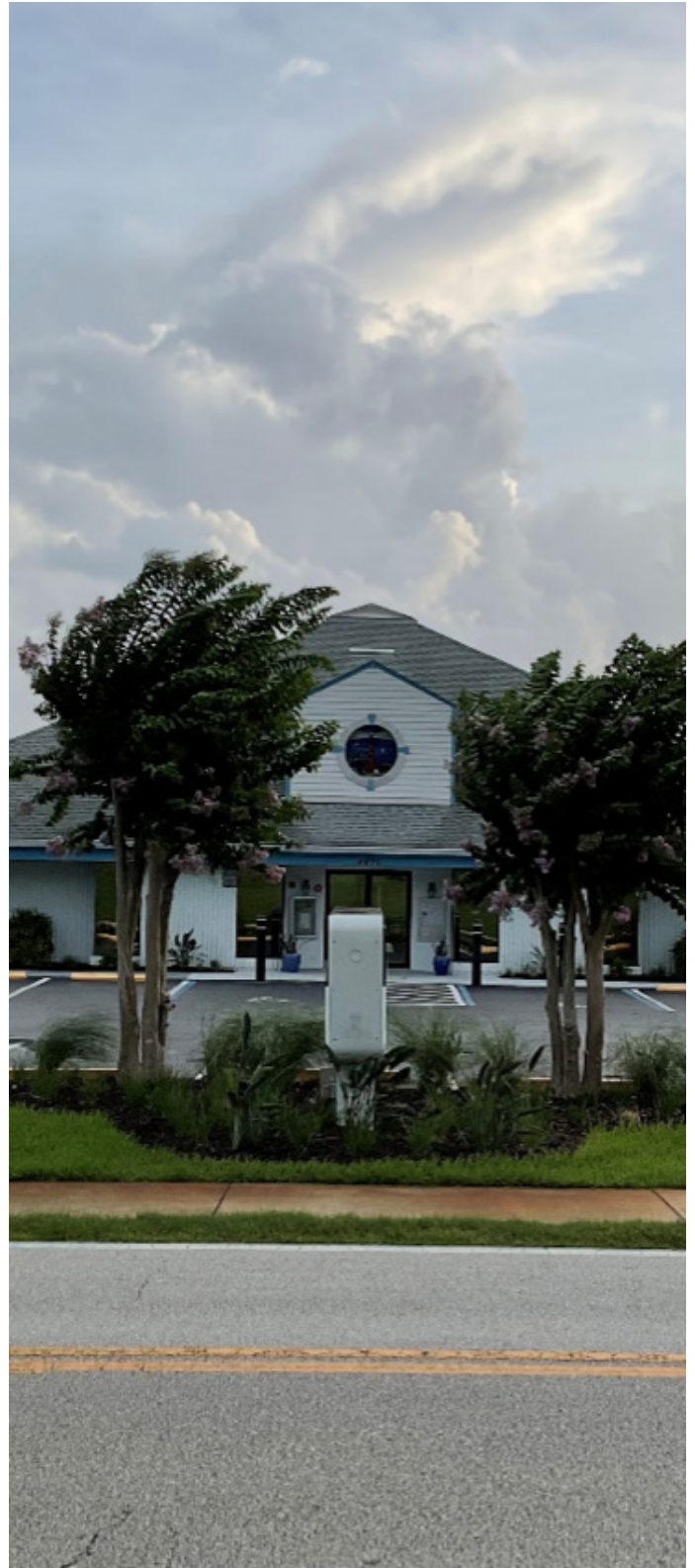

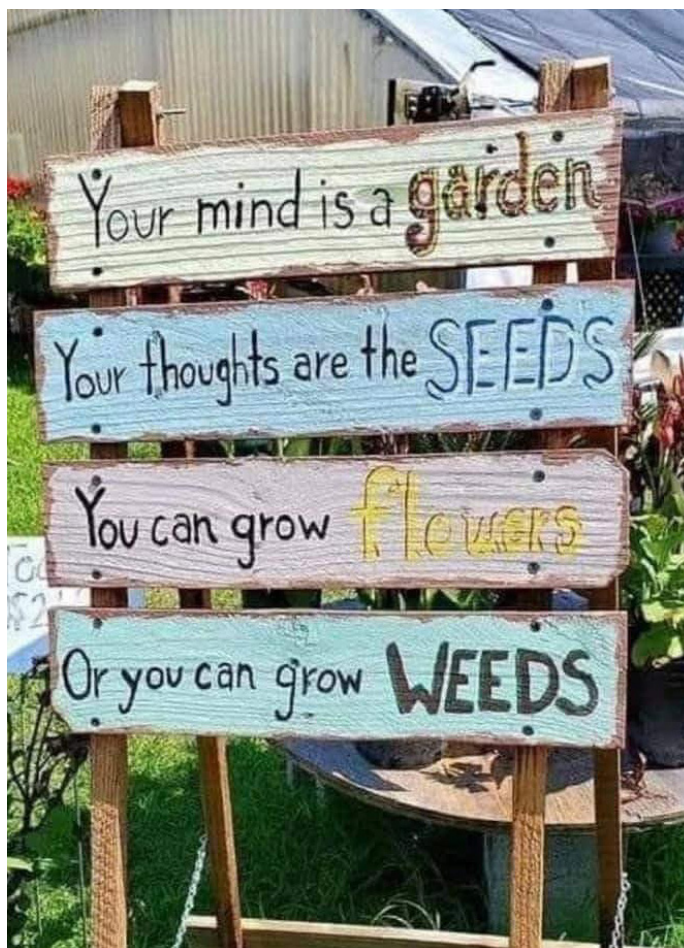


Happy Fall to all, and welcome to the 44th year of the Garden Club of Ponce Inlet!

to become a big winner by taking a chance to win our Scratch Off Lottery Tree!

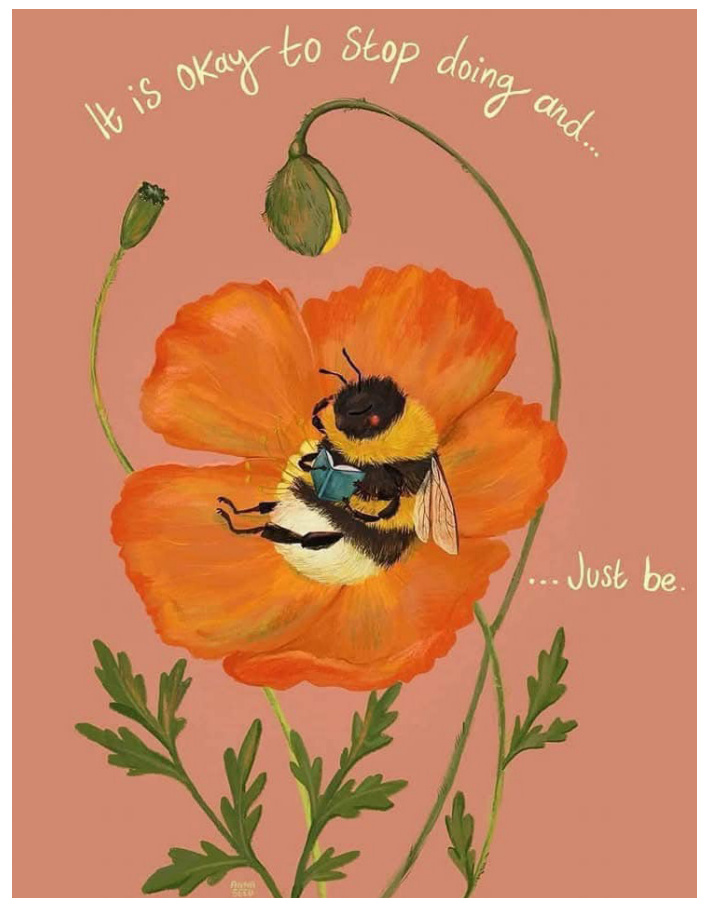

PONCE INLET ANIMAL WELFARE "PAW"

September 11th marks the 2016 passing of our co-founder, Jo Ellen Basile. She was a dedicated lover of all God's creatures, including sea turtles and cats. She and the late Alan Redinger were key players in working with the town to found Ponce Inlet Animal Welfare (PAW), with the input of two animal control officers from Ormond Beach.

JoEllen trapped several stray cats and provided care for them in her home until they were ready for adoption. According to records in my possession, at one time, there were over 200 dumpster-diving strays! Our trap-neuter-release to field (TNR) program has reduced that number to only an occasional stray cat, including the two who are full-time residents of our town-approved colony.

In addition to her longtime work with the cats, she was also a member of turtle patrol. She moved to Marathon Key, FL, to run the turtle hospital there. That was when Alan asked me to take over PAW as president. Jo Ellen returned to Ponce Inlet, but shortly afterward she was diagnosed with her second case of breast cancer. This time, it took her life.

I am told she had a beautiful voice that she used to praise the Lord at Ponce Church.

I regret that I never heard her sing, as she and I were not members of the church at the same time. If anyone has a recording, I would appreciate it if you would share it with me.

I often miss JoEllen and her wisdom about cats. She was the first person I knew who brought up the importance of buying BPA-free cans of cat food. It is now standard for canned food intended for human consumption.

Citizens for Ponce Inlet, Inc. has achieved 501(c)(3) status, marking a significant milestone in its more than 40-year history as an entirely volunteer-driven organization dedicated to serving the residents of Ponce Inlet. The organization's roots trace back over four decades, when it first embarked on a mission to conduct research, investigate various issues, and propose initiatives aimed at enhancing the quality of life in Ponce Inlet. Its primary objective was to collaborate with the Town Council in shaping a community that would be a source of pride for all. Today, this dedicated organization not only persists in pursuing these objectives but also annually recognizes and celebrates exceptional citizen volunteers through its Annual Awards Banquet. Among the accolades bestowed are the Citizen of the Year Award as well as various Lifetime Achievement Awards, reserved for residents who have generously volunteered for more than two decades.

Furthermore, CFPI, Inc./C4Pi hosts an annual Election Forum, providing residents with a valuable platform to engage with town council candidates. In a recent development, the organization introduced an Election Edition Newsletter, distributed via email to its C4Pi membership. This newsletter serves as a medium for candidates to address crucial community concerns and questions. In an effort to conserve funds, offer more information, and

adapt to the digital age, CFPI established the C4Pi.org website in 2019. This platform grants members the opportunity to access a digital quarterly newsletter, along with an extensive archive spanning over 40 years of past newsletters.
